INVITATION TO APPLY FOR ELIGIBILITY AND TO BID

Name of Project: CONTRACT FOR SECURITY SERVICES 2013

(To provide 1 chief security and 12 security guards for security services CY 2013)

The **MARITIME INDUSTRY AUTHORITY (MARINA)**, through the Republic Act No. 10352 otherwise known as General Appropriations Act for Fiscal Year 2013, dated 28 December 2012 intends to apply the sum of **P3,689,000.00** being the Approved Budget for the Contract (ABC) to be used as payment under the Contract for Security Services for 2013. Bids received in excess of the ABC shall be automatically rejected at Bid opening.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act." The Bidding is restricted to Filipino citizens/sole proprietorship, organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to Republic Act 5183 (R.A. 5183) and subject to Commonwealth Act 138 (C.A. 138), and who has experience in undertaking a similar project within the last five (5) years. Only Bids from Bidders who pass the eligibility check will be opened.

The process for the eligibility check is described in Section II of the Bidding Documents. The Bidder with the Lowest Calculated Bid (LCB) shall advance to the post-qualification stage in order to finally determine responsiveness of the bid to technical and financial requirements of the project. The contract shall then be awarded to the Lowest Calculated and Responsive Bidder (LCRB) who was determined as such during the post-qualifications procedure.

Interested Bidders may obtain further information from the MARINA and inspect the Bidding Documents at the address given below from **22 January – 13 February 2013.**

A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee in the amount of **fifteen thousand (P15,000) pesos.** The method of payment will be in cash. The Bidding Documents shall be received personally by the prospective Bidder or his authorized representative.

The MARINA will hold a Pre-Bid Conference open to all interested parties on **31 January 2013, 10:00 A.M.** at the MARINA Board Room, 4/F Parkview Plaza, 984 Taft Avenue corner T. M. Kalaw Street, Ermita, Manila.

Bids and eligibility requirements must be delivered to the address below on or before **13 February 2013, 8:00-10:00 A.M.** Prospective bidders have only until 10:00 A.M. on the same date to submit their bids. All Bids must be accompanied by a Bid security in the form of cash, bank draft/guarantee confirmed by a Universal or Commercial Bank or irrevocable letter of credit issued by a Universal or Commercial Bank: Provided however that it shall be confirmed or authenticated by a Universal or Commercial Bank if issued by a foreign bank (2% of ABC).

Bid opening shall be on **13 February 2013, 10:00 A.M.** at the MARINA Board Room, 4/F Parkview Plaza, 984 Taft Avenue corner T. M. Kalaw Street, Ermita, Manila.
