Nos. 197 and 218 under DOF-DBM Joint Circular No. 2000-2, the Maritime Industry Authority (MARINA) shall collect and impose the revised rates of Fees and Charges listed in ANNEX "A" hereof.

Any provision of existing MARINA Memorandum Circulars and issuances which are inconsistent with the Circular are hereby repealed/ modified accordingly.

This MARINA Circular shall take effect fifteen (15) days after its publication once in a newspaper of general circulation.
