## INVITATION TO BID

### SUPPLY AND DELIVERY OF TWO (2) UNITS BRAND NEW AIRCONDITIONED MINI-BUS FOR THE MARINA CENTRAL OFFICE

1. The MARITIME INDUSTRY AUTHORITY, through the General Appropriations Act of 2018 Capital Outlay intends to apply the sum of **Six Million Six Hundred Thousand Pesos (P6,600,000.00)** being the Approved Budget for the Contract (ABC) to payment under the contract for Supply and Delivery of two (2) units brand new airconditioned Mini-Bus for the MARINA Central Office. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The MARITIME INDUSTRY AUTHORITY now invites bids for Supply and Delivery of two (2) units brand new airconditioned Mini-Bus for the MARINA Central Office. Contract shall commence from the approval of Contract of Agreement and issuance of Notice to Proceed.
3. Bidder's Qualification:
  1. Must be at least five (5) years of operation in the Philippine market.
  2. Certification from Land Transportation Office (LTO)- accredited manufactures and importer attesting to the availability of authorized dealers and service centers in all regions of the country for at least five (5) years.
4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
5. A complete set of Bidding Documents may be acquired by interested Bidders from the address below and upon payment of a non-refundable fee for the Bidding Documents pursuant to the latest guidelines issued by the GPPB.
6. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and at [www.marina.gov.ph](http://www.marina.gov.ph), provided that Bidders shall pay the non-refundable fee of **Ten Thousand Pesos (P10,000.00) Only** for the Bidding Documents not later than the submission of their bids.
7. The MARITIME INDUSTRY AUTHORITY will hold a Pre-Bid Conference on **22 October 2018, 2:00 P.M. at MARINA Lounge, 4<sup>th</sup> floor Parkview Plaza, 984 Taft Avenue corner T. M. Kalaw Avenue, Ermita, Manila**, which shall be open to all prospective bidders.

8. Bid submission and opening shall be strictly observed based on the schedule below. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
