Passenger and Cargo Shipping Operations on 2/24/2021 in areas under MGCQ and GCQ Data generated on 2/24/2021, 3:00:00 PM


HIGHLIGHTS

- Ninety-Six percent (96%) of passenger and cargo shipping operations were completed in accordance with the ships' CPC.
- Four percent (4%) of the shipping operations were affected due to the measures implemented in view Code Red Sublevel 2 for the COVID-19.
- Operations of passenger ships were more affected compared to cargo ships. 98% of the cargo shipping operations were completed under normal conditions compared to passenger ships at 96%.
- With cargo shipping still operational, transport of goods amid MGCQ, and GCQ is assured.



I. STATUS OF SHIPPING OPERATIONS NATIONWIDE



On 2/24/2021, there were 109 passenger and cargo shipping operations conducted wherein 105 or 96% were completed in accordance with their Certificate of Public Convenience (CPC).

Out of the 105 operations completed under normal conditions, the reported movements were mostly in the Eastern Visayas Region at 36% and CARAGA Region at 33%.

Meanwhile, 1% of the passenger and cargo shipping operations were cancelled, all due to the community quarantine measures imposed by the different local government units governing the ships' ports of destination. Mostly affected were operations in the Central Visayas Region.

Two (2) passenger ships or 3% encountered delays due to the additional measures adopted in view of COVID-19 such as temperature screening and inspections.

Lastly, no shipping operations were not completed at the time of reporting.

II. STATUS OF SHIPPING OPERATIONS BY CLASSIFICATION

Amid the measures in place due to MGCQ, and GCQ, 39 out of 40 (98%) cargo ships still operated normally – are 7 bulk carrier, 1 container ship, 2 general cargo ships, 8 LCT ships, 19 Roro cargo ships and 2 other cargo.

Sixty-Six (66) passenger ships completed their voyage – 52 conventional passenger ships, 10 RoPax ships and 4 fast craft ferry completed their operations but mostly only carried cargoes during their voyage.

Meanwhile out of the 69 passenger ships, 4% were affected by the measures adopted in view of COVID-19. These measures caused either the cancellation, delay, or uncompleted operations of 3 passenger ships.
