
HIGHLIGHTS

- Eighty-Five percent (85%) of passenger and cargo shipping operations were completed in accordance with the ships' CPC.
- Fifteen percent (15%) of the shipping operations were affected due to the measures implemented in view Code Red Sublevel 2 for the COVID-19.
- Operations of passenger ships were more affected compared to cargo ships. 96% of the cargo shipping operations were completed under normal conditions compared to passenger ships at 58%.
- With cargo shipping still operational, transport of goods amid MGCQ, and GCQ is assured.



I. STATUS OF SHIPPING OPERATIONS NATIONWIDE



On 7/24/2021, there were 40 passenger and cargo shipping operations conducted wherein 34 or 85% were completed in accordance with their Certificate of Public Convenience (CPC).

Out of the 34 operations completed under normal conditions, the reported movements were mostly in the Bicol Region at 62% and Southern Mindanao Region at 32%.

Meanwhile, 3% of the passenger and cargo shipping operations were cancelled, all due to the community quarantine measures imposed by the different local government units governing the ships' ports of destination. Mostly affected were operations in the Central Visayas Region.

Four (4) passenger ships or 33% encountered delays due to the additional measures adopted in view of COVID-19 such as temperature screening and inspections.

Lastly, no shipping operations were not completed at the time of reporting.

Amid the measures in place due to MGCQ, and GCQ, 27 out of 28 (96%) cargo ships still operated normally – are 5 LCT ships and 22 Roro cargo ships.

Seven (7) passenger ships completed their voyage – 1 conventional passenger ships, 6 RoPax ships and 0 fast craft ferry completed their operations but mostly only carried cargoes during their voyage.

Meanwhile out of the 12 passenger ships, 42% were affected by the measures adopted in view of COVID-19. These measures caused either the cancellation, delay, or uncompleted operations of 5 passenger ships.
