**SUBJECT : PREPARATION FOR TROPICAL STORM “JOLINA”**

---

In view of the entry of Tropical Storm “Jolina” (Coson) into the Philippine Area of Responsibility (PAR) and to ensure safety of life at sea and the protection of the marine environment, **NOTICE** is hereby given on the following precautionary safety measures to be observed due to the inclement weather condition and in preparation thereof, to wit:

1. All shall strictly monitor and be updated on the latest weather bulletins issued by the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), as well as issuances from other Authorities such as the Philippine Coast Guard (PCG) relating to the sea state, gale warnings, and comply with the directives therein;
2. All ships / motorbancas shall not sail, except to take shelter, when their respective location or port of destination or area of operation is within a Public Storm Warning Signal based on the PAGASA weather bulletin.
3. All are hereby directed to comply with MARINA Advisory No. MS-2019-01 dated 20 December 2019 on the Strict Implementation of the Code of Safe Practice for Cargo Stowage and Securing in the Domestic Shipping;
4. All shall activate Emergency Procedures as per ISM Safety Management System (SMS) as appropriate and consistently maintain all communication lines between the ship, owner/operator, and Authorities.
5. All ships shall observe strict compliance with the Safety Standards / Procedures and Planned Maintenance System (PMS) under Company’s SMS;
6. All are hereby directed to monitor the safety and sheltering of your respective vessels, as appropriate; and
7. All are hereby directed to report any maritime incident to the MARINA Enforcement Service at Tel No. (02) 8524-9126 or email [es@marina.gov.ph](mailto:es@marina.gov.ph) or to the nearest MARINA Regional Office and PCG. (MRO-NCR email at [mroncr@marina.gov.ph](mailto:mroncr@marina.gov.ph))
