



# MARITIME INDUSTRY AUTHORITY SITUATION REPORT -649

Passenger and Cargo Shipping Operations on 01/01/22  
in areas under MGCQ and GCQ

## HIGHLIGHTS

- Ninety-Four percent (94%) of passenger and cargo shipping operations were completed in accordance with the ships' CPC.
- Six percent ( 6%) of the shipping operations were affected due to the measures implemented in view Code Red Sublevel 2 for the COVID-19.
- Operations of passenger ships were more affected compared to cargo ships. 100% of the cargo shipping operations were completed under normal conditions compared to passenger ships at 86%.
- **With cargo shipping still operational, transport of goods amid MGCQ, and GCQ is assured.**





## I. STATUS OF SHIPPING OPERATIONS NATIONWIDE



On 01/01/22, there were 50 passenger and cargo shipping operations conducted wherein 47 or 94% were completed in accordance with their Certificate of Public Convenience (CPC).

Out of the 47 operations completed under normal conditions, the reported movements were mostly in the Western Visayas Region at 26% and Eastern Visayas Region at 19%.

Three (3) passenger ships or 14% encountered delays due to the additional measures adopted in view of COVID-19 such as temperature screening and inspections.

Lastly, no shipping operations were not completed at the time of reporting.

Amid the measures in place due to MGCQ, and GCQ, 29 out of 29 (100%) cargo ships still operated normally – are 1 container ship, 2 LCT ships, 26 Roro cargo ships


Eighteen (18) passenger ships completed their voyage – 12 conventional passenger ships, 3 RoPax ships and 3 fast craft ferry completed their operations but mostly only carried cargoes during their voyage.

Meanwhile out of the 21 passenger ships, 14% were affected by the measures adopted in view of COVID-19. These measures caused either the cancellation, delay, or uncompleted operations of 3 passenger ships.


### PASSENGER Ship Operations




### CARGO Ship Operations
