Passenger and Cargo Shipping Operations on 02/01/22 in areas under MGCQ and GCQ Data generated on 02/01/22, 3:00:00 PM


HIGHLIGHTS

- Ninety-Five percent (95%) of passenger and cargo shipping operations were completed in accordance with the ships' CPC.
- Five percent (5%) of the shipping operations were affected due to the measures implemented in view Code Red Sublevel 2 for the COVID-19.
- Operations of passenger ships were more affected compared to cargo ships. 100% of the cargo shipping operations were completed under normal conditions compared to passenger ships at 89%.
- With cargo shipping still operational, transport of goods amid MGCQ, and GCQ is assured.

PASSENGER AND CARGO SHIPPING IN NUMBERS 02/01/22



Shipping Operations

I. STATUS OF SHIPPING OPERATIONS NATIONWIDE



On 02/01/22, there were 78 passenger and cargo shipping operations conducted wherein 74 or 95% were completed in accordance with their Certificate of Public Convenience (CPC).

Out of the 74 operations completed under normal conditions, the reported movements were mostly in the Eastern Visayas Region at 45% and Bicol Region at 24%.

Four (4) passenger ships or 11% encountered delays due to the additional measures adopted in view of COVID-19 such as temperature screening and inspections.

No shipping operations were not completed at the time of reporting.

Amid the measures in place due to MGCQ, and GCQ, 42 out of 42 (100%) cargo ships still operated normally – are 1 container ships, 9 LCT ships, 32 Roro cargo ships.

Thirty-two (32) passenger ships completed their voyage – 16 conventional passenger ships, 10 RoPax ships and 6 fast craft ferry completed their operations but mostly only carried cargoes during their voyage.

Meanwhile out of the 36 passenger ships, 11% were affected by the measures adopted in view of COVID-19. These measures caused either the cancellation, delay, or uncompleted operations of 4 passenger ships.
