Subject: 2021 amendments to the Convention on the International Maritime Organization

- 1 The Secretary-General has the honour to refer to the amendments to Articles 16, 17, 18, 19(b) and 81 of the IMO Convention adopted on 8 December 2021 by the Assembly at its thirty-second session, by resolution A.1152(32).
- 2 Pursuant to Article 72 of the IMO Convention, on 7 February 2022, the amendments were circulated by the Secretary-General of the United Nations to all Members of the Organization for acceptance (C.N.46.2022).
- 3 Pursuant to Article 73 of the IMO Convention, an instrument of acceptance of the amendments shall be communicated to the Secretary-General of IMO, for deposit with the Secretary-General of the United Nations. The Secretary-General of IMO will notify Members of the receipt of any such instrument and of the date when the amendment enters into force.
- 4 The Secretary-General also refers to Assembly resolution A.1172(32), which, among other things:
 - .1 urges the Members of the Organization to accept these amendments as soon as possible, with the goal of entry into force of these amendments by 2025;
 - .2 invites the Secretary-General to provide any assistance needed with respect to the acceptance of the amendments to those Members who request it; and
 - .3 also invites the Secretary-General to actively promote acceptance of the amendments to Members.
- To these ends, and to assist Members in the early acceptance of the amendments, the annex to this circular letter contains a model instrument of acceptance of the amendments. The Secretary-General stands ready to provide any further assistance to Members who request it and encourages Members to accept the amendments at their earliest convenience.
