Subject: FSO SAFER - UN call for contributions towards oil spill response

equipment

- Since 2019, IMO has been part of the UN-wide efforts to prevent a spill from FSO SAFER, an aging floating storage offshore (FSO) unit containing an estimated 150,000 metric tonnes of oil cargo. It is currently moored off the coast of Yemen near, in the Gulf of Aden. IMO has particularly focussed on contingency planning efforts in the event of a spill from FSO SAFER.
- 2 On 9 March, the UN Development Programme (UNDP) signed an agreement to purchase the VLCC that will take on the oil, marking a major step toward starting the planned ship-to-ship transfer operation, making tangible progress towards eliminating the threat of a catastrophic oil spill from FSO SAFER.
- 3 In line with this significant step forward, contingency planning efforts are intensifying in preparation for the upcoming transfer operation.
- One of the critical oil spill preparedness gaps identified in Yemen refers to the lack of specialized oil spill response equipment within the country. Consequently, it is considered of great importance to address the necessary measures for any required immediate response in the event of an oil spill from FSO SAFER.
- Taking into account the significant manufacturing lead times for the acquisition of oil spill response equipment, the UN would welcome in-kind contributions of spill response equipment, including used equipment, to support preparedness efforts, in the event of a spill from FSO SAFER.
- To assist the process, an indicative list of the required oil spill response equipment is set out at annex. Taking into account that operations are provisionally scheduled to initiate in early May 2023, it would be necessary for the required equipment to be in region as soon as practicably possible.
