The Maritime Industry Authority (MARINA), a government agency established pursuant to Presidential Decree No. 474 (1974) and attached to the Department of Transportation (DoTr), wishes to invite quotations from interested transportation entities to provide the needed logistical requirements for bus transportation (Manila to Baguio City, v.v.) for the conduct of MARINA Mid-Year Performance Assessment and Planning Conference on 26-28 June 2022 at a suitable venue outside Metro Manila.

II. Objective

The MARINA Mid-Year Performance Assessment and Planning Conference is conducted every mid of the year to ensure the continuous assessment, planning and effectiveness in complying with its policies and standards and to address issues and concerns of the Agency.






