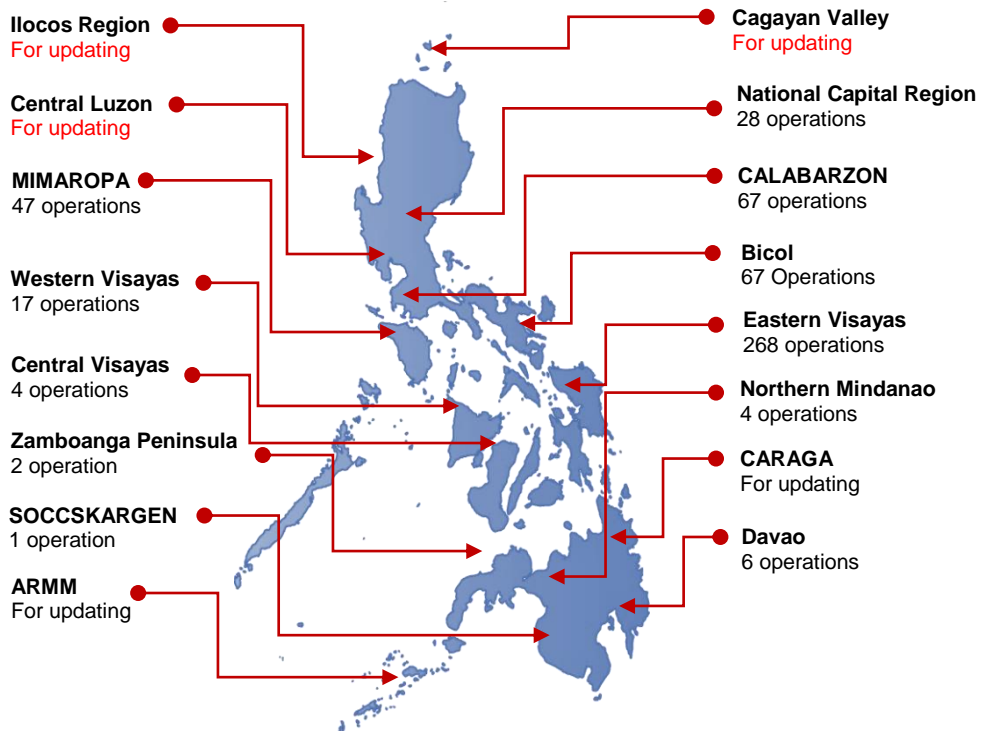
HIGHLIGHTS

- Ninety-nine percent (99%) of passenger and cargo shipping operations were completed in accordance with the ships' CPC.
- One percent (1%) of the shipping operations were affected.
- Operations of passenger ships were more affected compared to cargo ships. 100% of the cargo shipping operations were completed under normal conditions compared to passenger ships at 97%.
- Daily average passenger and cargo ship operations are 126 completed under normal conditions, 0 cancelled trips, 2 delayed and 0 not completed voyage.
- **With cargo shipping still operational, transport of goods is assured.**

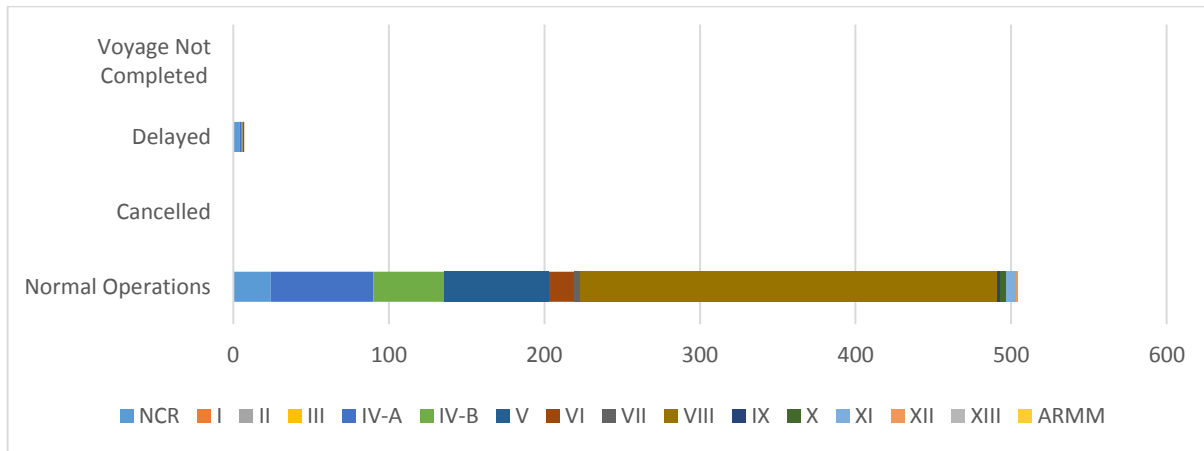

I. STATUS OF SHIPPING OPERATIONS NATIONWIDE



On Nov. 11 - 17, 2022, there were 511 passenger and cargo shipping operations conducted wherein 504 or 99% were completed in accordance with their Certificate of Public Convenience (CPC).

Out of the 504 operations completed under normal conditions, the reported movements were mostly in the Eastern Visayas Region at 53% and CALABARZON Region at 13%.

Seven (7) passenger ships or 3% encountered delays.

Lastly, no shipping operations were not completed at the time of reporting, as the respective ships were still underway.

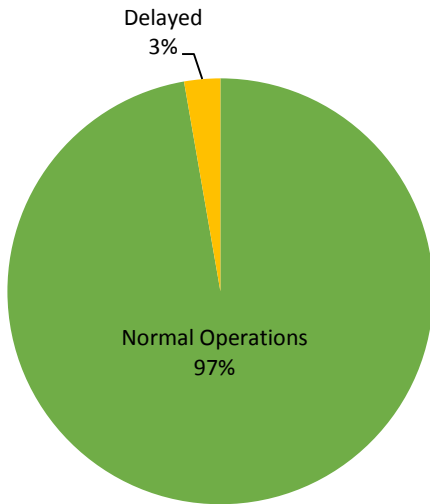

Amid the measures in place due to MGCQ, and GCQ, 255 out of 255 (100%) cargo ships still operated normally – are 21 bulk carrier, 45 container ships, 38 LCT ships, 151 Roro cargo ships.

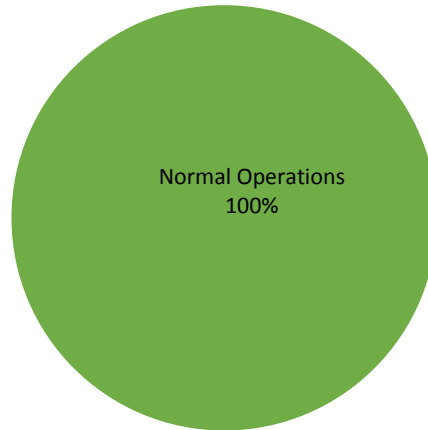
Two hundred and forty-nine (249) passenger ships completed their voyage – 167 conventional passenger ships, 51 RoPax ships and 31 fast craft ferry completed their operations but mostly only carried cargoes during their voyage.

Meanwhile out of the 256 passenger ships, 3% were affected by the measures adopted in view of COVID-19. These measures caused either the cancellation, delay, or uncompleted operations of 7 passenger ships.

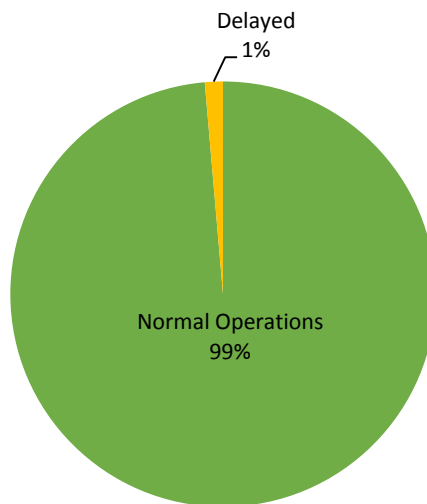
PASSENGER Ship Operations



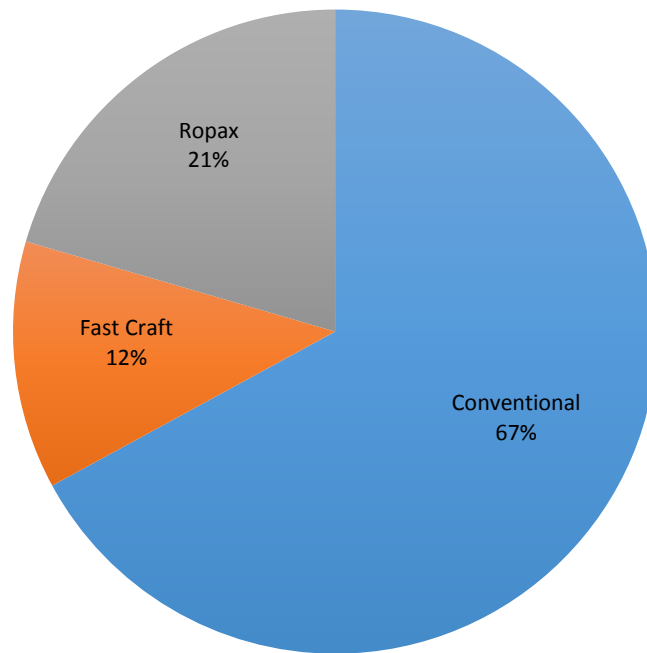
CARGO Ship Operations



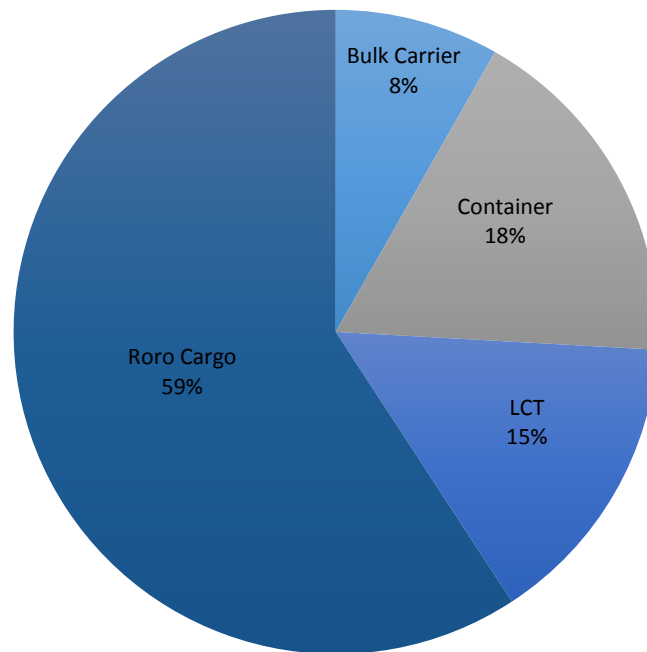

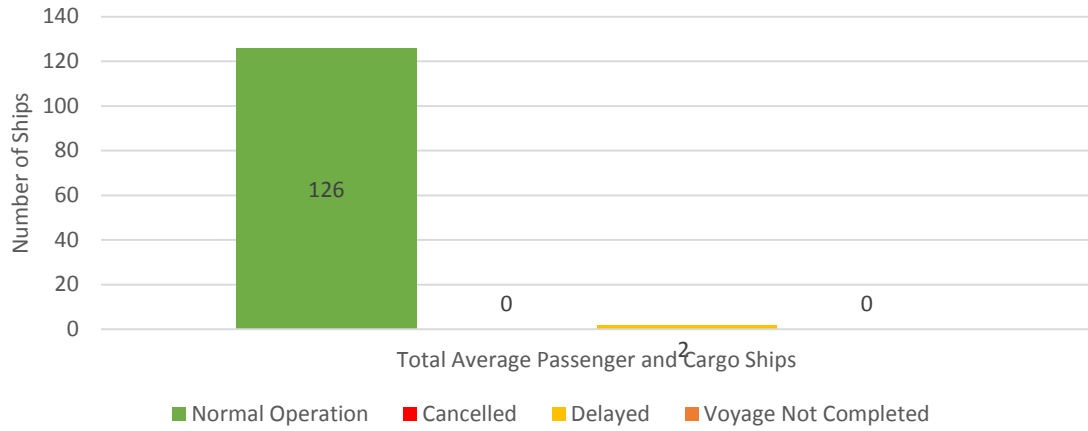
Passenger Ship Types under Normal Operations



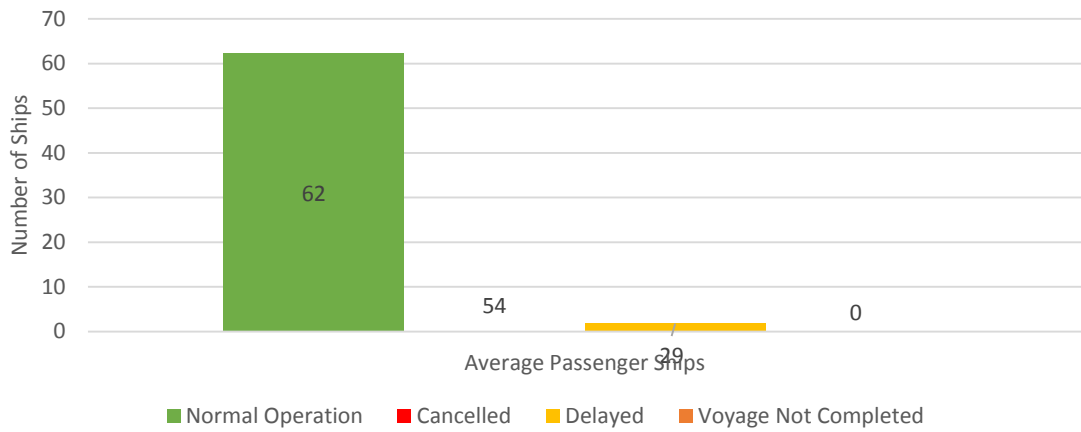
Cargo Ship Types under Normal Operations
