MARINA LEADS PH DELEGATION TO IMO HTW 10 SESSION IN LONDON

The Philippine delegation, led by the Maritime Industry Authority (MARINA), attended the 10th session of the Sub-Committee on Human Element, Training and Watchkeeping (HTW) held at the IMO headquarters in London, UK. The HTW deals with the human side of shipping, including training and certification; the review, updating and revision of IMO model courses; as well as guidance addressing issues such as fatigue and wellbeing of seafarers.

The ongoing session continues the work started in HTW 9 on the comprehensive review of the STCW Convention and the STCW Code. The review is carried out to deal with cyber security and emerging technologies, as well as issues on bullying and harassment, including sexual assault and sexual harassment. Likewise, the quality of onboard training,

PBBM APPROVES...

In a four-page Executive Order No. 55 signed by Executive Secretary Lucas P. Bersamin on February 8, President Marcos cited the need to approve and adopt the MIDP to fully realize the potential of the Philippines as a maritime nation.

"To fully realize our potential as a maritime nation, the country requires a clearly defined and coordinated roadmap that shall accelerate the integrated development of the Philippine Maritime Industry," President Marcos said.

The President said the MIDP envisions a strong and reliable Philippine Merchant Fleet, which addresses sea transport requirements in support of national development, consistent with the country's "AmBisyon Natin 2024" of a strongly rooted, comfortable and secure life for all Filipinos.

He said the MARINA Board shall adopt a system for the effective implementation, monitoring and review of the MIDP, and component programs, which include modernization and expansion of domestic shipping and promotion, expansion of the overseas shipping industry.

The plan is highly focused on enhancing the Philippine Merchant Fleet, expanding domestic and overseas shipping industries, and promoting a skilled maritime workforce aligns perfectly with our goals of economic growth and global competitiveness.

The MARINA also stressed the staunch support of the Department of Transportation (DOTr), headed by Secretary Jaime J. Bautista, in the development and updating of the MIDP. The collaborative efforts between the Agency, the DOTr along with its partner agencies have been

The modernization, expansion and promotion of shipbuilding and ship repair industry; promotion of highly-skilled and competitive maritime workforce; enhancement of maritime transport safety and security; and promotion of environmentally sustainable maritime industry are also part of the component programs.

Component programs also include the implementation of a sustainable maritime innovation, transformation, digitalization and knowledge center; and adoption of an effective and efficient maritime administration governance system.

All government agencies and align instrumentalities must also and harmonize their policies and courses of action to ensure its effective implementation while an MIDP Technical Board (TB) is created to assist the board in implementing, monitoring, updating and reviewing the program.

The MIDP TB will be composed of MARINA Board representatives with rank not lower than of an Assistant Secretary, or its equivalent while the board may invite or enjoin participation of other relevant agencies or instrumentalities as additional members, whenever necessary in the performance and functions of the MIDP TB. and measures to facilitate mandatory seagoing service are also discussed. The session also follows through the move for ensuring just transition for seafarers in view of decarbonization in the maritime sector.

In HTW 10, the Philippines participated in finalizing the draft list of areas under the STCW Convention and STCW Code which will be subjected to review, the draft methodology which will be adopted to tackle the work, and the road map of activities which are aimed to culminate in 2027. Lessons learned from previous comprehensive amendments, particularly during the Manila Amendments in 2010 were recalled as basis for establishing Inter-Sessional Working Groups (ISWG) and Correspondence Groups which will be convened to ensure effective coordination and avoid any unintended consequences that may arise from adopting changes.

The Philippines co-sponsored two papers in HTW 10: Reports on unlawful practices associated with Certificates of Competency which was submitted with Japan and Panama; and the Proposal to incorporate recommendations on Polar Code training programs which was submitted with Argentina, Canada, Chile, Georgia, Malaysia, South Africa and Türkiye.

During the session, two model courses were validated: IMO Model Course 1.32 on Operational use of integrated bridge systems including integrated navigation systems, and IMO Model Course 1.35 on Liquefied Petroleum Gas (LPG) tanker cargo and ballast handling simulator.

MARINA, GLOBAL GREEN GROWTH **INSTITUTE SIGN** MOU



The Maritime Industry Authority (MARINA) and the Global Green Growth Institute (GGGI) signed a Memorandum of Understanding (MOU) at the MARINA Central Office, to strengthen cooperation on green growth initiatives in the maritime industry on 14 February 2024.

In a significant stride towards advancing the standards of maritime education in the country, the newly reconstituted Technical Panel for Maritime Education (TPME) held its oath taking ceremony administered by CHED Chair J. Prospero De Vera III on 16 February 2024 at the Commission on Higher Education (CHED) Central Office.

The ceremony marks the commencement of MARINA Administrator Sonia B. Malaluan's pivotal role of shaping policies and standards related to maritime education in the Philippines. Under the Administrator's guidance, the Technical Panel aims to address current challenges, incorporate industry advancements, and enhance the curriculum to meet global standards.

She also stressed the need for a stronger and unified partnership, not only between MARINA and CHED but with all stakeholders, encouraging a whole-of-nation approach.

The program also included a ceremonial signing of a Memorandum of Agreement (MOA) between CHED and the Center for Educational Measurement, Inc. (CEM). This MOA pertains to the development of the National Maritime Admission Test (NaMMAT), which aims to ensure that only qualified students are granted entry to the BS Maritime program.

Speaking at the ceremony, Mr. Silvius expressed his gratitude for the opportunity to know MARINA up close and looks forward to more opportunities like this. He emphasized that beyond the signing of an MOU, the real and actual collaboration that will take place from now on involves the meeting of minds and brainstorming on how both parties could move forward. "We (GGGI) are here to support you. Your program, your ideas, your vision on green growth we will push or pull a little bit, and perhaps bring forth fresh and new ideas, new innovation in the process." he affirmed.

He further expressed his support for more collaboration as a result of the approved Maritime Industry Development Plan (MIDP).

For her part, Administrator Malaluan expressed her gratitude and enthusiasm for how GGGI pursued MARINA and initiated this cooperation on green growth in light of decarbonization.

"We at the Maritime Industry Authority (MARINA) continue to foster the much-needed collaboration with governments, businesses, and civil societies in support of the IMO's GHG Strategy, such as the decarbonization of international shipping, and eventually, will redound to domestic shipping as well.", she added.

The MARINA also intends to establish a satellite office in Batanes to facilitate the issuance of certificates and other necessary requirements of boat operators and maritime stakeholders in Region 2.

MARINA BOLSTERS SAFETY AND SECURITY MEASURES IN RORO PASSENGER SHIPS

In a proactive move to enhance safety and security measures within the maritime sector, the Maritime Industry Authority (MARINA) has intensified its efforts by spearheading Compliance Monitoring activities across Visayas and Mindanao regions from January 23rd to February 7th, 2024.

Led by its Enforcement Service (ES), three specialized teams were deployed to various locations in these regions to meticulously assess and verify the compliance of RoRo passenger ships with safety regulations mandated by the Administration. Leveraging technical assistance from the French Government, MARINA enforcers were equipped to conduct comprehensive compliance monitoring in adherence to existing safety protocols governing domestic ships. This initiative, endorsed by the MARINA Administrator, underscores the unwavering Administration's commitment ensuring the safety and security of the traveling public.

Moreover. the Enforcement Service information feedback implemented a swift mechanism, fostering direct engagement with passengers and stakeholders. During onboard inspections, QR Code stickers were prominently displayed, enabling passengers to provide real-time feedback, whether it be complaints, comments, or commendations regarding services or safety

concerns. MARINA promptly addresses any issues raised, further reinforcing its dedication to maintaining high standards of safety and service within the maritime industry.

The MARINA – STCW Office conducted a coordination meeting with the Health Facilities and Services Regulatory Bureau (HFSRB) of the Department of Health (DOH). The meeting is part of MARINA's commitment to actively collaborate with partner agencies to sustain the full and complete implementation of the STCW Convention, 1978, as amended.

The HFSRB is the service unit of the DOH responsible for the accreditation of Medical Facilities for Overseas Workers and Seafarers (MFOWS) and recognition of Medical Practitioners (MPs) assessing the medical fitness of seafarers for service at sea.

The meeting provided an opportunity to refresh on the requirements of Regulation I/9 on Medical Standards. Concerns related to enrolment of MFOWS and MPs in the surveillance, accreditation and monitoring information system (SAM-IS) of MARINA was also discussed. Issues encountered from actual medical certificates submitted by seafarers and the corresponding information encoded by MFOWS in the MARINA Integrated Seafarers Management Online (MISMO) System were also jointly reviewed to streamline the process of issuance of Certificates of Competency (COC) and Certificates of Proficiencies (COP) to seafarers.

MARINA CONDUCTS SPECIALIZED TRAINING OF TRAINERS FOR IGF COURSE, STRENGTHENING PHL'S READINESS FOR IMO STRATEGY ON GHG EMISSION REDUCTION

In preparation for the Philippines' compliance with the IMO Strategy on the reduction of GHG Emissions from ships, the STCW Office of the Maritime Industry Authority (MARINA), in collaboration with the Philippine Center for Advanced Maritime Simulation and Training (PHILCAMSAT), and Kongsberg Digital AS, conducted a Training of Trainers for the IGF Course. The Opening Program on 20 February 2024 at PHILCAMSAT in Makati City was led by STCW Office Executive Director Samuel L. Batalla.

Recognizing capacity development as one of the key elements in complying with international conventions, in which the Philippines is a party, and consistent with the 10-year Maritime Industry Development Plan 2028 (MIDP), this initiative highlights a strategic approach towards fulfilling obligations and enhancing maritime capabilities in response to global standards and emerging technologies.

The Training of Trainers for the IGF Course was conducted to ensure that there will be a sufficient pool of qualified instructors and assessors accredited by MARINA. The course covered simulation exercises on bunkering, firefighting, and extinguishing operations. It also covered a review on the principles of adult

learning and the preparation of the Instructor's Guide. It can be recalled that MARINA issued standards for both Basic and Advanced Training for Ships Subject to IGF Courses in 2020. To date, seven (7) training providers are approved to conduct the Basic Course, and four (4) are approved for the Advanced Course.

The specialized Training of Trainers for the IGF Course was facilitated by Capt. Quentin N. Cox and C/E Sherrain Dominguez from PHILCAMSAT, and Ms. Presca Lee B. Lugo from the STCW Office of MARINA. Capt. Archievald Camba and Mr. Donnie Bagang of Green Marine Engineering (Singapore) served as validators for the training.

Cooperation (SMART-C) Programme during the inception meeting held at the MARINA Building, Port Area, Manila on 28 February 2024.

As defined by the IMO, the SMART-C Programme aims to promote sustainable maritime transport systems and the marine environment through knowledge-building and technical capacity in developing countries via long-term projects. The SMART-C Programme is composed of various projects, with the Philippines being one of the beneficiary countries: a) SMART-C Women Project; b) SMART-C Traffic Project; and c) SMART-C GHG Project.

The SMART-C Women Project aims to contribute gender equality by increasing employment opportunities for women in the maritime sector in developing countries and providing training to help women advance their careers in related industries. The SMART-C GHG Project, on the other hand, is intended to support developing countries in decarbonizing the shipping sector by establishing a management and analysis system for GHG emission data from ships. Lastly, the SMART-C Traffic Project aims to develop, operate, and pilot an e-navigation service that can efficiently analyze and manage maritime safety information in an internet-based environment.

The Maritime Industry Authority (MARINA) and CMA CGM Philippines discussed the important matters in the Philippine maritime industry particularly in domestic shipping, maritime safety and marine environment protection.

MARINA Administrator Sonia Malaluan underscored the possible areas of collaboration that would contribute to the enhancement of ease of doing business, operational flexibility, as well as the improvement of the domestic shipping and maritime industry in general.

During the meeting at the MARINA Central Office, Port Area, Manila on 08 February 2024, the two parties also talked about the digitization project of the MARINA that will streamline the process of necessary requirements on the operations of ships and MC DS-2023-02 on the implementation of RA 11659 entitled "An Act Amending Commonwealth Act No. 146, otherwise known as the Public Service Act, as amended."

The MARINA and CMA CGM Philippines also briefly discussed the implementation of MARINA Circular No. SR-2020-06, particularly the provision of all Philippine registered ships plying in domestic $trade\ compliance\ with\ the\ 0.50\%\ m/m\ fuel\ oil\ Sulphur$ content limit by 01 January 2025. The MARINA has been reviewing the position of different shipping companies on the implementation of the said policy.

MARINA BUILDING CONSTRUCTION IN MISAMIS ORIENTAL NOW 54%

EXECUTIVE ORDER NO. 55

ADOPTING THE TEN-YEAR MARITIME INDUSTRY DEVELOPMENT PLAN 2028

WHEREAS, Presidential Decree (PD) No. 474 (s. 1974) or the "Maritime Industry Decree of 1974," as amended, created the Maritime Industry Authority (MARINA) to accelerate the integrated development of the maritime industry of the Philippines;

WHEREAS, Section 5 of PD No. 474 mandated the preparation and annual updating of a Ten (10)-Year Maritime Industry Development Program (MIDP) that contains a rational and integrated development plan of the maritime industry for submission to, and approval by, the President;

WHEREAS, to fully realize our potential as a maritime nation, the country requires a clearly defined and coordinated roadmap that shall accelerate the integrated development of the Philippine Maritime Industry;

WHEREAS, the MIDP envisions a strong and reliable Philippine Merchant Fleet that addresses the sea transport requirements of the archipelago in support of national development, consistent with the country's AmBisyon Natin 2040 of a strongly rooted, comfortable and secure life for all Filipinos;

WHEREAS, the Administration's Eight (8)-Point Socioeconomic Agenda seeks to improve transportation and the Philippine Development Plan 2023-2028 aims to enhance inter-sectoral linkages by accelerating the development of a globally competitive maritime industry while positioning the country as a key aviation hub in Asia:

WHEREAS, to ensure the effective implementation of the MIDP, it is imperative that all government agencies and instrumentalities align and harmonize their policies and courses of action with the 10-Year MIDP; and

WHEREAS, Section 17, Article VII of the Constitution vests in the President the power of control over all Executive departments, bureaus and offices, and ensure the faithful execution of laws.

and instrumentalities with relevant mandates. Representatives to the TWG/s shall have a rank not lower than that of a Director or its equivalent.

The MIDP TB and the TWGs shall meet every quarter, or as frequently as may be deemed necessary by the MARINA Administrator or the MARINA Board.

The MARINA shall provide secretariat services to the MIDP TB and its TWGs.

Section 4. Functions of the MIDP Technical Board. The MIDP TB shall perform the following functions, subject to the control and supervision of the MARINA Board:

- Review, monitor and recommend approval of MIDP-related policies and programs to the MARINA Board;
- Periodically conduct comprehensive review of the MIDP, using evidence-driven approaches and internationally recognized standards and best practices, and develop pertinent policy and implementation guidelines thereof for the approval of the MARINA Board;
- c. Establish an integrated database and information system following a specific statistical framework for the maritime industry which will address the information needed for monitoring, reviewing and updating the MIDP-related policies and programs, in coordination with the Philippine Statistics Authority;
- d. Prepare progress and performance reports for review and information of the MARINA Board; and
- Perform other functions as may be requested by the MARINA Administrator or the MARINA Board

Section 5. Funding. The funding requirements for the implementation of this Order shall be charged against current and available appropriations of MARINA and other relevant agencies, subject to pertinent budgeting, accounting, and auditing laws, rules and regulations. Thereafter, the funding requirements necessary for the continued implementation of this Order shall be included in the budget proposals of the MARINA and other relevant agencies, subject to the usual budget preparation process.

Section 6. Communication Plan. The MARINA shall implement the Communication Plan included as part of the MIDP, in coordination with the Presidential Communications Office.

Section 7. Report. A progress report on the status of implementation of this Order and the MIDP shall be submitted by the MARINA to the Office of the President, through the Office of the Executive Secretary, within six (6) months from the implementation of this Order, and every year thereafter. NOW, THEREFORE, I, FERDINAND R. MARCOS JR, President of the Philippines, by virtue of the powers vested in me by the Constitution and existing laws, do hereby order:

Section 1. Adoption and Implementation. Pursuant to Section 5 of PD No. 474, the Maritime Industry Development Plan 2028 is hereby approved and adopted as the whole of nation roadmap for the integrated development and strategic direction of the maritime industry.

Towards this end, the MARINA Board shall adopt a system for the effective implementation, monitoring and review of the MIDP, and its component programs as follows:

- a. Modernization and expansion of domestic shipping;
- b. Promotion and expansion of the overseas shipping industry;
- c. Modernization, expansion and promotion of shipbuilding and ship repair industry;
- d. Promotion of highly-skilled and competitive maritime workforce;
- e. Enhancement of maritime transport safety and security;
- f. Promotion of environmentally sustainable maritime industry;
- g. Implementation of a sustainable maritime innovation, transformation, digitalization and knowledge center; and
- h. Adoption of an effective and efficient maritime administration governance system.

Section 2. Convergence. Pursuant to Section 5 of PD No. 474, all relevant national government agencies and instrumentalities, including government-owned or -controlled corporations, government financial institutions, and state universities and colleges, are hereby directed, and all local government units are hereby encouraged, to implement the MIDP, as well as the plans, programs and strategies identified therein that are relevant to their respective mandates.

Section 3. MIDP Technical Board. An MIDP Technical Board (TB) is hereby created to assist the MARINA Board in the implementation, monitoring, updating and review of the MIDP.

The MIDP TB shall be initially composed of the representatives of the MARINA Board under Section 7 of PD No. 474, with rank not lower than that of an Assistant Secretary or its equivalent. The MARINA Board may invite or enjoin participation of other relevant agencies or instrumentalities as additional members, whenever necessary in the performance and functions of the MIDP TB.

The MARINA Board may create technical working groups (TWG) based on the component programs identified in the MIDP, consisting of representatives of agencies

Section 8. Separability. If any section or part of this Order is declared unconstitutional or invalid, the other sections or provisions not otherwise affected shall remain in full force and effect

Section 9. Repeal. All other orders, guidelines, rules, regulations, and issuances or parts thereof, which are inconsistent with the provisions of this Order, are hereby repealed or modified accordingly.

Section 10. Effectivity. This Order shall take effect immediately upon publication in the Official Gazette or in a newspaper of general circulation.
