 Rate Adjustment under Republic Act No. 10963, otherwise known as the "Tax Reform for Acceleration and Inclusion (TRAIN) Law"

Notice is hereby given that the Maritime Industry Authority (MARINA) will implement the new rate of Documentary Stamp Tax (DST), increasing the amount from Php15.00 to Php30.00 per certificate/document, pursuant to the Bureau of Internal Revenue (BIR) Revenue Regulations No.4-2018 dated December 19, 2017 on the following Certificates/Documents issued by this Authority:
