Registration certificate from Securities and Exchange Commission (SEC) for corporation, Department of Trade and Industry (DTI) for sole proprietorship, or Cooperative Development Authority (CDA) for cooperatives, or any proof of such registration as stated in the Bidding Documents;</p> <p>ii. Mayor's permit issued by the city or municipality where the principal place of business of the prospective bidder is located.</p>	<p>To clarify query of bidder if they can only submit their Certificate of Registration and Platinum membership with PhilGEPS in lieu of the Eligibility Requirements "Class A" Documents</p> <p>The bidders have to submit the Eligibility Requirements as prescribed in page 12 of the bidding documents.</p> <p>This is in view of GPPB's issuance of Circular No. 03-2016 dated 27 October 2016 Delaying Implementation of the Mandatory Submission of PhilGEPS Certificate of Registration and Membership in Competitive Bidding which is up to 30 April 2017.</p>
