TERMS OF REFERENCE (TOR) FOR THE PROCUREMENT OF RESOURCE SPEAKER FOR THE CONDUCT OF A THREE (3) DAY LIVE-OUT SEMINAR WORKSHOP ON ADVANCED LEGAL RESEARCH ON 29-31 MAY 2018 WITHIN METRO MANILA

RATIONALE

The Maritime Industry Authority (MARINA), a government agency established pursuant to Presidential Decree No. 474 (1974) and attached to the Department of Transportation (DOTr), wishes to invite quotations from interested entities to the MARINA-STCW Office one (1) Resource Speaker for the conduct of a three (3)-day live-out seminar workshop on Advanced Legal Research on 29-31 May 2018 at a suitable venue in Metro Manila.

OBJECTIVE

The objective of this activity is to provide participants the knowledge and competency in legal analysis, print and online research, and objective writing, among others.

EXPECTED OUTPUT

Knowledge and familiarity of the participants with foundational legal sources, including the 1987 constitution, statutes, jurisprudence, administrative law, legislative history, and secondary sources as well.

METHODOLOGY

The seminar/workshop will be conducted through a combination of lecture, group discussions and group dynamics (workshops). Likewise, participants will be encouraged to involve themselves through clarifications with the Resource Speaker. To make learning process active and light, other activities and processes shall be employed by the Resource Speaker.

MINIMUM QUALIFICATIONS OF THE RESOURCE SPEAKER

The Provider-Resource Speaker must be able to establish at least five (5) years of experience in conducting related seminar workshop. Moreover, he/she must have conducted at least three (3) similar trainings in any government office.

There shall be a total of twenty-six (26) participants and two (2) Secretariat composed of MARINA personnel appearing in the attached Special Order.
