SUBJECT : COVERAGE OF MEMORANDUM CIRCULAR NO. 2007-01 ON THE DOUBLE HULL REQUIREMENTS FOR TANKERS CARRYING HEAVY GRADE OIL AND OTHER PERSISTENT OILS

Notice is hereby given that by virtue of Regulation IV.A of MARINA Memorandum Circular No. 2007-01, oil tankers including tankers below 600 tons shall be double hulled by April 2008.

In view hereof, the following single hulled vessels have not been granted extension to carry heavy grade oil products as of this date:

Further, all concerned are informed that applicants for extension to carry heavy grade oil products with the use of single hulled tankers must still post or submit the required cash bond per vessel under MARINA Flag State Advisory No. 2008-07. The Orders of the Office of the President (OP) dated October 20, 2008 and

November 18, 2008 in the case O.P. Case No. 08-J-396 (Chelsea Shipping Corporation vs. MARINA, et. al.) merely restrains this Authority in collecting the twenty five thousand pesos (Php25,000.00) per day of operation as contained in FSA 2008-07.

All Maritime Enforcers are ordered to apprehend the above vessels or any single hulled tanker or barge carrying heavy grade oil products without approved extension from this Authority.

This also serves as a Notice to oil companies that the above tankers are not allowed to carry heavy grade oil products.

This Advisory takes effect immediately.
