**IDENTIFICATION AND RECORD SHEET (SIRS)** 

Please be informed that in view of the disruption in the supply and schedule of of our Philippine Seafarers deliveries to replenish our depleted stocks notice is hereby given that the Maritime Identification and Record Books (SIRB), Industry Authority (MARINA) shall be issuing Philippine Seafarers the Identification and Record Sheet (SIRS) in lieu of the SIRB starting on 05 March 2014 to Filipino seafarers requiring the same in connection with their immediate deployment. The SIRS shall be valid for one (1) year. It has the following salient features:

- The SIRS is printed on MARINA security paper with visible and invisible fibers
- The SIRS contains the biographical data of the holder
- The SIRS shall be verifiable on line at www.marina.gov.ph/verifySIRB

Further, please be advised that all entries related to sea service in the SIRS are required to be filled up by the ship's Officers. In accordance with the Philippine maritime rules and regulations, sea service entries shall serve as reference of this Authority during the application for renewal of SIRB by any Filipino seafarer.
