Page 57 Bidder's Qualifications	<p><i>To clarify that the Bidder's qualifications in the Terms of Reference (TOR), page 10 and in the Technical Specifications, page 69 shall prevail.</i></p> <ul style="list-style-type: none">• Bidders must have completed/installed electronic document tracking or records management system with amount equivalent to fifty percent (50%) of the ABC within two(2) years from the date of submission of receipt of bids.• Completed at least three (3) similar projects in supply, delivery and installation of computer hardware, within the last three(3) years. This should be vouched by a Certificate of Acceptance issued by the end user.• The bidder should have been operating in the Philippines for at least five (5) years and is registered with SEC or DTI.
