INVITATION TO BID

PROCUREMENT OF GENERATOR SET (GENSET) AND ACCESSORIES FOR THE MARITIME INDUSTRY AUTHORITY CENTRAL OFFICE BUILDING

1. The MARITIME INDUSTRY AUTHORITY, through the General Appropriations Act of 2018 Capital Outlay intends to apply the sum of **Five Million Pesos (P5,000,000.00)** inclusive of all applicable taxes and charges, being the Approved Budget for the Contract (ABC) to payment under the contract for the procurement of one (1) GENSET and accessories. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The MARITIME INDUSTRY AUTHORITY now invites bids for the procurement of one (1) GENSET and Accessories for the aforementioned Project. Contract shall commence from the approval of Contract of Agreement and issuance of Notice to Proceed.
3. **Bidder's Qualifications:**
 - Preferably with 5 years industry experience in the supply of generators set.
 - Must secure the necessary Permits and Licenses for the permissible operation of the GENSET (National/Local/Barangay/DENR, etc.)

4. Bidding will be conducted through open competitive bidding procedures using a non- discretionary "pass/fail" criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

5. A complete set of Bidding Documents may be acquired by interested Bidders from the address below and upon payment of a non-refundable fee for the Bidding Documents pursuant to the latest guidelines issued by the GPPB.
6. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and at **www.marina.gov.ph** provided that Bidders shall pay the non-refundable fee of **Five Thousand Pesos (P5,000.00) Only** for the Bidding Documents not later than the submission of their bids.
7. The MARITIME INDUSTRY AUTHORITY will hold a Pre-Bid Conference on **15 August 2018, 3:00 P.M. at MARINA Lounge, 4th Floor Parkview Plaza, 984 Taft Avenue corner T. M. Kalaw Avenue, Ermita, Manila**, which shall be open to all prospective bidders.
8. Bid submission and opening shall be strictly observed based on the schedule below. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
