- 1. Dispensation Permit in case of death or injury to the crew onboard; extension of servicing of lifeboat/liferaft, emergency drydocking and other similar and analogous circumstances.
- 2. Letter authorization to Recognized Organization (RO) under the following circumstances:
 - a. if there is an accident during the voyage of the Philippine-registered overseas ships;
 - b. detention of Philippine-registered ships by other Port State Control authorities;
 - c. malfunction of the ship's equipment including, but not limited to, defective gyro compass, alarm monitoring system, radio equipment or oil water incinerator;
 - d. damaged liferaft or lifeboat;
 - e. other deficiencies that may occur during the ship's voyage; and,
 - f. other similar and analogous circumstances.
- 3. Incident Reports with regard to Philippine-registered ships.

III. REQUIREMENTS

Filing of request/report via email including, but not limited to: name of the concerned shipping company, name of ship, reason/s for the request, duration, name of RO, itinerary of the ship and other relevant information necessary to the request.

IV. PROCEDURE

- 1. Urgent requests/reports may be directly coursed through:
 - a. For dispensation permits, extension of servicing of lifeboat/liferaft and emergency drydocking, and other similar analogous circumstances.
