INVITATION TO BID

SUPPLY, DELIVERY, INSTALLATION AND CONFIGURATION OF COMPUTER HARDWARE FOR THE OFFICE PRODUCTIVITY PROJECT

The MARITIME INDUSTRY AUTHORITY, through the 2019 National Expenditure Program (NEP) for Capital Outlay and MOOE intends to apply the sum of **TWELVE MILLION NINE HUNDRED THREE THOUSAND PESOS (₱12,903,000.00)** for the Supply, Delivery, Installation and Configuration of Computer Hardware for the Office Productivity Project. Bids received in excess of the ABC shall be automatically rejected at bid opening.

1. The MARITIME INDUSTRY AUTHORITY now invites bids for the Supply, Delivery, Installation and Configuration of Computer Hardware for the Office Productivity Project. Contract shall commence from the approval of Contract of Agreement and issuance of Notice to Proceed.
2. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
3. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
4. A complete set of Bidding Documents may be acquired by interested Bidders from the address stated in item no. 9.1 and upon payment of a non-refundable fee for the Bidding Documents pursuant to the latest guidelines issued by the GPPB.
5. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and at www.marina.gov.ph, provided that Bidders shall pay the non-refundable fee of **Twenty Five Thousand Pesos (₱25,000.00)** for the Bidding Documents not later than the submission of their bids.

6. The MARITIME INDUSTRY AUTHORITY will hold a Pre-Bid Conference at **MARINA Lounge, 4th Floor 984 Parkview Plaza, Taft Avenue corner T.M. Kalaw Avenue, Ermita, Manila**, which shall be open to all prospective bidders.
