Vessel Registration

All Licensed Recreational Boats operated in Philippine Territorial waters must be registered with the Philippines' Recreational BoatRegistry. A laminated copy of the Vessels Registration must be carried on board at all times when the vessel is in use.

Registration Markings

All Licensed Recreational Boats must properly and clearly display its Official Number at the bow portion of the vessel on vessels such as Rigid Inflatables and other boats. Where it is difficult to affix or paint on the marking it may be affixed or painted anywhere it can easily be read from outside the Craft on its superstructure or elsewhere. Markings may be painted on or an acceptable Vinyl Sticker material or plates of metal, wood, or plastic, secured to a readily accessible visible permanent part of the structure with rivets, through bolts with the ends clenched, or screws with the slots removed may also be used.

Communications

- 1. Marine Band VHF Radio with Channel 16
 - a. Class C hand held
 - b. Class B Fixed Mount
 - c. Class A Fixed Mount
- 2. Satellite Messaging Device
 - a. A satellite tracker capable of sending a distress message via text message to a predefined set of Mobile Numbers
 - b. Subscription of this must be up to date.
 - c. A laminated screen shot of current subscription must be on board
 - d. Unit must be:
 - i. Fully Charged for rechargeable units with charger and charging port available on board
 - ii. 1 set brand new spare batteries in original packaging must be on board for units requiring off the shelf batteries to the correct specifications such as Lithium batteries for SPOT trackers.

Labeling of Locations for Safety Equipment

Locations of Lifejackets, Liferafts must be clearly marked with waterproof Stickers or Legibly Painted on.

Personal Flotation Devices (PFDs)

Only MARINA, IACS Member, competent bodies recognized by the MARINA (i.e. SOPI, DOST, DTI, Bureau of Product Standards, NTC, other maritime administration (e.g. USCG Type I, II, III) approved PFDs may be used.

1 PFD per passenger on board must be available.

For Infants and Children the correct specification and size PFD must be available and given to the parent / Guardian before every voyage.

Wearable PFDs must be readily accessible, meaning you must be able to put them on in a reasonable amount of time in an emergency (vessel sinking, on fire, etc.). They should not be stowed in plastic bags, in locked or closed compartments or have other gear stowed on top of them.

Life Rings

Life Rings are required on vessels 26 feet or more in length. There must be one 24" in diameter life ring with MARINA or CG approval #160.050. The life ring must be readily available to be thrown to a person in the water.

Fire Extinguishers

All fire extinguishers must be an HFC 236fa Type and they must be within the operating dates indicated. It is recommended the extinguishers be mounted in a readily accessible position. Minimum number of fire extinguishers required:

Backfire Flame Control

Gasoline engines installed in a recreational boat except outboard motors, must be equipped with an acceptable means of backfire flame control. The device must be suitably attached to the air intake with a flame tight connection.

Sound Producing Device

Whistle or horn or a bell. This may be mounted onto the Vessel or Hand Held but must be located where it is easily accessible to the Captain.

Navigation

<u>Fixed Mount Chart Plotter</u> with Electronic Map of the Philippines, Must have a minimum 5" screen.

Compass Marine Grade fix mount compass (class c hand held)

Laminated Chart of the area of operation: NAMRIA Nautical Chart

<u>Radar</u> or also know as a Marine Radar are used to detect other ships and land obstacles, to provide bearing and distance for collision avoidance and navigation at sea.

Navigation Lights

Class C: Minimum Portable battery operated Red and Green Bi Color Light Class B and A: Fixed Mount Sidelight (Red Green Bi Color Light), Mast Head Light (White All around Light at Highest Point), Stern Light (White).

Use: Red Light (Port) Green Light (Starboard) At Anchor: Mast Head Light must be ON Under Power: All lights must be ON
