INVITATION TO BID

SUPPLY, DELIVERY AND INSTALLATION OF VIDEO AND AUDIO EQUIPMENT SYSTEMS FOR THE MARINA CENTRAL OFFICE (2nd Bidding)

The MARITIME INDUSTRY AUTHORITY, through the 2019 General Appropriations Act (GAA) for Capital Outlay intends to apply the sum of **TEN MILLION FIVE HUNDRED THOUSAND PESOS** (₱10,500,000.00) for the SUPPLY, DELIVERY AND INSTALLATION OF VIDEO AND AUDIO EQUIPMENT SYSTEMS FOR THE MARINA CENTRAL OFFICE. Bids received in excess of the ABC shall be automatically rejected at bid opening.

- The MARITIME INDUSTRY AUTHORITY now invites bids for the SUPPLY, DELIVERY AND INSTALLATION OF VIDEO AND AUDIO EQUIPMENT SYSTEMS FOR THE MARINA CENTRAL OFFICE. Contract shall commence from the approval of Contract/Agreement and issuance of Notice to Proceed.
- 2. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
- 3. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
- 4. A complete set of Bidding Documents may be acquired by interested Bidders from the address stated in item no. 7.1 and upon payment of a non-refundable fee for the Bidding Documents pursuant to the latest guidelines issued by the GPPB.
- 5. The bidding documents may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and at www.marina.gov.ph, provided that Bidders shall pay the non-refundable fee of Twenty-Five Thousand Pesos (₱25,000.00) for the Bidding Documents not later than the submission of their bids.

- 6. The MARITIME INDUSTRY AUTHORITY will hold a Pre-Bid Conference on 27 November 2019, 2:00 P.M. at the Board Room, 3rd Floor, MARINA Building, A. Bonifacio Drive corner 20th Street, Port Area, Manila, which shall be open to all prospective bidders.
