TERMS OF REFERENCE FOR THE PROCUREMENT OF 12-DOOR LOCKER

I. INTRODUCTION

The Maritime Industry Authority (MARINA), a government agency established pursuant to Presidential Decree No. 474 (1974) and attached to the Department of Transportation (DOTr) has identified the necessity to procure 12-Door Lockers for the use of examinees for the theoretical examination for Marine Deck and Engineer Officers of the Examination and Assessment Division, Standards of Training, Certification and Watchkeeping for Seafarers (STCW) Office.

Pursuant to the Revised Implementing Rules and Regulation of RA 9184, procurement with the approved contact of One Million Pesos P1,000,000.00 or less can be done through Small Value Procurement.

II. RATIONALE AND OBJECTIVES

This project aims to seek proposals from competent and eligible bidders/suppliers to supply and deliver twelve (12) units of 12-Door Lockers to be used by the examinees for MARINE Deck and Engineer Officers Theoretical Examination.

III. APPROVED BUDGET FOR THE CONTRACT

An amount of One Hundred and Forty-Four Thousand Pesos (Php144,000.00) only, inclusive of all applicable government taxes and charges.

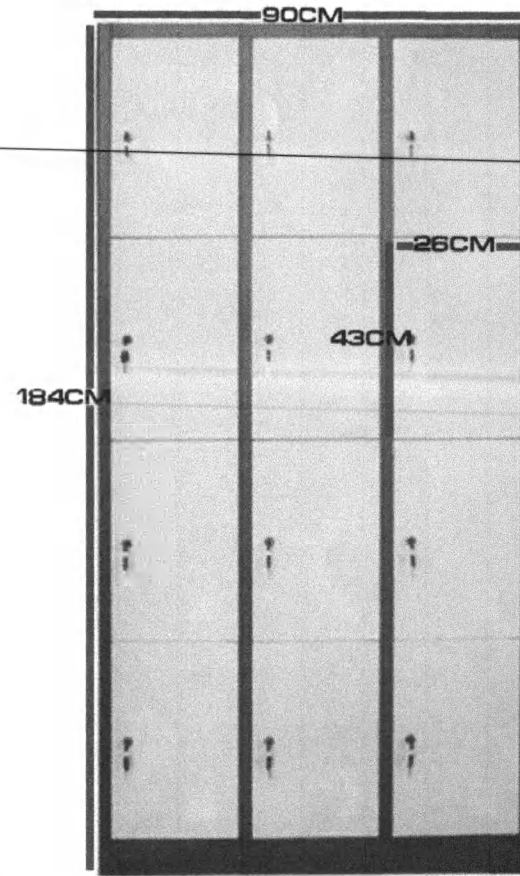
Items shall be delivered 7 (seven) days upon receipt of Notice to Proceed (NTP)
