

MARITIME INDUSTRY AUTHORITY SITUATION REPORT – 35

Passenger and Cargo Shipping Operations on 27 April 2020 amid Code Red Sublevel 2 for the COVID-19

Data generated on 27 April 2020, 3:00 PM

HIGHLIGHTS

- Sixty-nine percent (69%) of passenger and cargo shipping operations were completed in accordance with the ships' CPC.
- Thirty-one percent (31%) of the shipping operations were affected due to the measures implemented in view Code Red Sublevel 2 for the COVID-19.
- Operations of passenger ships were more affected compared to cargo ships. 82% of the cargo shipping operations were completed under normal conditions compared to passenger ships at 62%.
- With cargo shipping still operational, transport of goods amid Enhanced Community Quarantine is assured.





PASSENGER AND CARGO SHIPPING OPERATIONS IN THE PHILIPPINES AMID CODE RED SUBLEVEL 2 FOR THE COVID-19



I. STATUS OF SHIPPING OPERATIONS NATIONWIDE



On April 27, 2020, there were 254 passenger and cargo shipping operations conducted wherein 175 or 69% were completed in accordance with their Certificate of Public Convenience (CPC).

Out of the 175 operations completed under normal conditions, the reported movements were mostly in the Calabarzon Region and Mimaropa Region both at 26%.

Meanwhile, 17% of the passenger and cargo shipping operations were cancelled, all due to the community quarantine measures imposed by the different local government units governing the ships' ports of destination. Mostly affected were operations in the Western Visayas and Central Visayas Regions.

Thirteen (13) passenger and cargo ships or 5% encountered delays due to the additional measures adopted in view of COVID-19 such as temperature screening and inspections.

Lastly, eleven (11) passenger and eleven (11) cargo shipping operations were not completed at the time of reporting, as the respective ships were still underway.

Amid the measures in place due to Code Red Sublevel 2 on COVID-19, 73 out of 89 (82%) cargo ships still operated normally - 11 are container ships, 9 general cargo ships, 20 LCT ships, 1 bulk carrier, 25 oil tankers, 5 Roro ships, and 2 other types.

One hundred two (102) passenger ships completed their voyage – 89 conventional passenger ships, 11 RoPax ships and 2 other types completed their operations but mostly only carried cargoes during their voyage.

Meanwhile out of the 165 passenger ships, 38% were affected by the measures adopted in view of COVID-19. These measures caused either the cancellation, delay, or uncompleted operations of 63 passenger ships.
