

MARITIME INDUSTRY AUTHORITY SITUATION REPORT – 59

Passenger and Cargo Shipping Operations on 21 May 2020 amid Code Red Sublevel 2 for the COVID-19

Data generated on 21 May 2020, 1:00 PM

HIGHLIGHTS

- Sixty-four percent (64%) of passenger and cargo shipping operations were completed in accordance with the ships' CPC.
- Thirty-six percent (36%) of the shipping operations were affected due to the measures implemented in view Code Red Sublevel 2 for the COVID-19.
- Operations of passenger ships were more affected compared to cargo ships. 72% of the cargo shipping operations were completed under normal conditions compared to passenger ships at 62%.
- With cargo shipping still operational, transport of goods amid Enhanced Community Quarantine is assured.





PASSENGER AND CARGO SHIPPING OPERATIONS IN THE PHILIPPINES AMID CODE RED SUBLEVEL 2 FOR THE COVID-19



I. STATUS OF SHIPPING OPERATIONS NATIONWIDE



On May 21, 2020, there were 169 passenger and cargo shipping operations conducted wherein 109 or 64% were completed in accordance with their Certificate of Public Convenience (CPC).

Out of the 109 operations completed under normal conditions, the reported movements were mostly in the Calabarzon Region at 31% and Mimaropa, Western Visayas, Central Visayas Regions at 15%.

Meanwhile, 26% of the passenger and cargo shipping operations were cancelled, all due to the community quarantine measures imposed by the different local government units governing the ships' ports of destination. Mostly affected were operations in the Central Visayas and Western Visayas Regions.

Fifteen (15) passenger ships or 9% encountered delays due to the additional measures adopted in view of COVID-19 such as temperature screening and inspections.

Lastly, only one (1) passenger shipping operation was not completed at the time of reporting, as the respective ship was still underway.

Amid the measures in place due to Code Red Sublevel 2 on COVID-19, 26 out of 36 (72%) cargo ships still operated normally – are 1 chemical tanker, 1 container ship, 5 general cargo ships, 14 oil tankers, and 5 Roro cargo ships.

Eightty-three (83) passenger ships completed their voyage – 69 conventional passenger ships, 13 RoPax ships and 1 fast craft ferry completed their operations but mostly only carried cargoes during their voyage.

Meanwhile out of the 133 passenger ships, 38%% were affected by the measures adopted in view of COVID-19. These measures caused either the cancellation, delay, or uncompleted operations of 50 passenger ships.
