- TO: ALL SEAFARERS, MARITIME TRAINING INSTITUTIONS (MTIs), ASSESSMENT CENTERS (ACs), MARITIME HIGHER EDUCATION INSTITUTIONS (MHEIS), SHIPOWNERS AND SHIPPING COMPANIES, CREWING AND MANNING AGENCIES, AND OTHER ENTITIES CONCERNED
- SUBJECT: AMENDMENT TO STCW ADVISORY NO. 2019-08 EXTENDING FURTHER THE DEADLINE TO COMPLETE AND PASS THE ASSESSMENT OF COMPETENCE OF SEAFARERS UNDER STCW CIRCULAR NOS. 2014-08 TO 2014-13, 2016-13 AND 2016-17 (OLD SYSTEM)

In line with the relevant provisions of MARINA Advisory No. 2020-16 which set forth seafarer-related guidelines to be observed during the period of Enhanced Community Quarantine (ECQ) which was declared due to the Coronavirus Disease 2019 (COVID-19) pandemic, Notice is hereby given that the conditions on the deadline set to complete and pass the theoretical and practical assessments of seafarers stated in STCW Advisory No. 2019-08-are hereby further **EXTENDED**, as follows:

## 1. THEORETICAL EXAMINATION

All seafarers who failed to comply with the given deadline shall no longer be accepted and shall retake all assessment of competence under the provisions of STCW Circular Nos. 2018-08 or 2018-09, as applicable.

Further, all seafarers who took the theoretical examination under STCW Circular Nos. 2014-08 to 2014-13, 2016-13 and 2016-17 (OLD SYSTEM) shall likewise take the practical assessment under the same Circulars and all accredited Assessment Centers (ACs) are enjoined to ensure and observe this.

All provisions in STCW Advisory No. 2019-08 which are contrary or inconsistent with this Advisory are hereby superseded, repealed or amended accordingly.
