

### **MARITIME INDUSTRY AUTHORITY SITUATION REPORT - 87**

Passenger and Cargo Shipping Operations on June 18, 2020 in areas under MECQ, MGCQ, and GCQ

Data generated on June 18, 2020, 3:00 PM

#### **HIGHLIGHTS**

- Eighty-two percent (82%) of passenger and cargo shipping operations were completed in accordance with the ships' CPC.
- Eighteen percent (18%) of the shipping operations were affected due to the measures implemented in view Code Red Sublevel 2 for the COVID-19.
- Operations of passenger ships were more affected compared to cargo ships. 89% of the cargo shipping operations were completed under normal conditions compared to passenger ships at 79%.
- With cargo shipping still operational, transport of goods amid MECQ, MGCQ, and GCQ is assured.





# PASSENGER AND CARGO SHIPPING OPERATIONS IN THE PHILIPPINES IN AREAS UNDER MECQ, MGCQ and GCQ



### I. STATUS OF SHIPPING OPERATIONS NATIONWIDE



On June 18, 2020, there were 262 passenger and cargo shipping operations conducted wherein 214 or 82% were completed in accordance with their Certificate of Public Convenience (CPC).

Out of the 214 operations completed under normal conditions, the reported movements were mostly in the Calabarzon Region at 29% and Mimaropa Region at 20%.

Meanwhile, 14% of the passenger and cargo shipping operations were cancelled, all due to the community quarantine measures imposed by the different local government units governing the ships' ports of destination. Mostly affected were operations in the Central Visayas and Eastern Visayas Regions.

Only one (1) passenger ship or 1% encountered delay due to the additional measures adopted in view of COVID-19 such as temperature screening and inspections.

Lastly, five (5) passenger and four (4) cargo shipping operations were not completed at the time of reporting, as the respective ships were still underway.

Amid the measures in place due to MECQ, MGCQ, and GCQ, 56 out of 63 (89%) cargo ships still operated normally – are 11 container ships, 2 general cargo ships, 25 LCT ships, 16 oil tankers and 2 Roro cargo ships.

One hundred fifty-eight (158) passenger ships completed their voyage – 135 conventional passenger ships, 22 RoPax ships and 1 fast craft ferry completed their operations but mostly only carried cargoes during their voyage.

Meanwhile out of the 199 passenger ships, 21% were affected by the measures adopted in view of COVID-19. These measures caused either the cancellation, delay, or uncompleted operations of 41 passenger ships.
