

MARITIME INDUSTRY AUTHORITY SITUATION REPORT - 91

Passenger and Cargo Shipping Operations on June 22, 2020 in areas under MECQ, MGCQ, and GCQ

Data generated on June 22, 2020, 3:00 PM

HIGHLIGHTS

- Seventy-nine percent (79%) of passenger and cargo shipping operations were completed in accordance with the ships' CPC.
- Twenty-one percent (21%) of the shipping operations were affected due to the measures implemented in view Code Red Sublevel 2 for the COVID-19.
- Operations of passenger ships were more affected compared to cargo ships. 85% of the cargo shipping operations were completed under normal conditions compared to passenger ships at 78%.
- With cargo shipping still operational, transport of goods amid MECQ, MGCQ, and GCQ is assured.





PASSENGER AND CARGO SHIPPING OPERATIONS IN THE PHILIPPINES IN AREAS UNDER MECQ, MGCQ and GCQ



I. STATUS OF SHIPPING OPERATIONS NATIONWIDE



On June 22, 2020, there were 201 passenger and cargo shipping operations conducted wherein 159 or 79% were completed in accordance with their Certificate of Public Convenience (CPC).

Out of the 159 operations completed under normal conditions, the reported movements were mostly in the Eastern Visayas Region at 23% and Calabarzon Region at 22%.

Meanwhile, 10% of the passenger and cargo shipping operations were cancelled, all due to the community quarantine measures imposed by the different local government units governing the ships' ports of destination. Mostly affected were operations in the Central Visayas and Mimaropa Regions.

Nineteen (19) passenger ships or 12% encountered delays due to the additional measures adopted in view of COVID-19 such as temperature screening and inspections.

Lastly, no passenger and cargo shipping operation was not completed at the time of reporting.

Amid the measures in place due to MECQ, MGCQ, and GCQ, 34 out of 40 (85%) cargo ships still operated normally – are 7 container ships, 1 general cargo ship, 14 LCT ships, 1 oil tanker and 11 Roro cargo ships.

One-hundred twenty-five (125) passenger ships completed their voyage – 113 conventional passenger ships and 12 RoPax ships completed their operations but mostly only carried cargoes during their voyage.

Meanwhile out of the 161 passenger ships, 22% were affected by the measures adopted in view of COVID-19. These measures caused either the cancellation, delay, or uncompleted operations of 36 passenger ships.
