

MARITIME INDUSTRY AUTHORITY SITUATION REPORT - 133

Passenger and Cargo Shipping Operations on August 03, 2020 in areas under MGCQ and GCQ

Data generated on August 03, 2020, 3:00 PM

HIGHLIGHTS

- Seventy-seven percent (77%) of passenger and cargo shipping operations were completed in accordance with the ships' CPC.
- Twenty-three percent (23%) of the shipping operations were affected due to the measures implemented in view Code Red Sublevel 2 for the COVID-19.
- Operations of passenger ships were more affected compared to cargo ships. 86% of the cargo shipping operations were completed under normal conditions compared to passenger ships at 74%.
- With cargo shipping still operational, transport of goods amid MECQ, MGCQ, and GCQ is assured.





PASSENGER AND CARGO SHIPPING OPERATIONS IN THE PHILIPPINES IN AREAS UNDER MGCQ and GCQ



I. STATUS OF SHIPPING OPERATIONS NATIONWIDE



On August 03, 2020, there were 185 passenger and cargo shipping operations conducted wherein 142 or 77% were completed in accordance with their Certificate of Public Convenience (CPC).

Out of the 142 operations completed under normal conditions, the reported movements were mostly in the Eastern Visayas Region at 28% and Calabarzon Region at 16%.

Meanwhile, 12% of the passenger and cargo shipping operations were cancelled, all due to the community quarantine measures imposed by the different local government units governing the ships' ports of destination. Mostly affected were operations in the Central Visayas and Eastern Visayas Regions.

Sixteen (16) passenger ships or 11% encountered delays due to the additional measures adopted in view of COVID-19 such as temperature screening and inspections.

Lastly, no passenger and cargo shipping operation was not completed at the time of reporting.

Amid the measures in place due to MECQ, MGCQ, and GCQ, 32 out of 37 (86%) cargo ships still operated normally – are 2 container ships, 1 general cargo ship, 18 LCT ships, 1 oil tanker and 10 Roro cargo ships.

One-hundred ten (110) passenger ships completed their voyage – 89 conventional passenger ships and 21 RoPax ships completed their operations but mostly only carried cargoes during their voyage.

Meanwhile out of the 148 passenger ships, 26% were affected by the measures adopted in view of COVID-19. These measures caused either the cancellation, delay, or uncompleted operations of 38 passenger ships.
