

MARITIME INDUSTRY AUTHORITY SITUATION REPORT - 142

Passenger and Cargo Shipping Operations on August 12, 2020 in areas under MECQ, MGCQ and GCQ

Data generated on August 12, 2020, 3:00 PM

HIGHLIGHTS

- Eighty-three percent (83%) of passenger and cargo shipping operations were completed in accordance with the ships' CPC.
- Seventeen percent (17%) of the shipping operations were affected due to the measures implemented in view Code Red Sublevel 2 for the COVID-19.
- Operations of passenger ships were more affected compared to cargo ships. 95% of the cargo shipping operations were completed under normal conditions compared to passenger ships at 80%.
- With cargo shipping still operational, transport of goods amid MECQ, MGCQ, and GCQ is assured.





PASSENGER AND CARGO SHIPPING OPERATIONS IN THE PHILIPPINES IN AREAS UNDER MECQ, MGCQ and GCQ



I. STATUS OF SHIPPING OPERATIONS NATIONWIDE



On August 12, 2020, there were 179 passenger and cargo shipping operations conducted wherein 149 or 83% were completed in accordance with their Certificate of Public Convenience (CPC).

Out of the 149 operations completed under normal conditions, the reported movements were mostly in the Eastern Visayas Region at 26% and Calabarzon Region at 20%.

Meanwhile, 4% of the passenger and cargo shipping operations were cancelled, all due to the community quarantine measures imposed by the different local government units governing the ships' ports of destination. Mostly affected were operations in the Central Visayas, Calabarzon and Northern Mindanao Regions.

Twenty-two (22) passenger ships or 16% encountered delays due to the additional measures adopted in view of COVID-19 such as temperature screening and inspections.

Lastly, no passenger and cargo shipping operation were not completed at the time of reporting, as the respective ships were still underway.

Amid the measures in place due to MECQ, MGCQ, and GCQ, 37 out of 39 (95%) cargo ships still operated normally - are 1 general cargo ship, 13 LCT ships, 17 oil tankers and 6 Roro cargo ships.

One hundred and twelve (112) passenger ships completed their voyage – 96 conventional passenger ships and 16 RoPax ships completed their operations but mostly only carried cargoes during their voyage.

Meanwhile out of the 140 passenger ships, 20% were affected by the measures adopted in view of COVID-19. These measures caused either the cancellation, delay, or uncompleted operations of 28 passenger ships.
