

MARITIME INDUSTRY AUTHORITY SITUATION REPORT - 188

Passenger and Cargo Shipping Operations on September 27, 2020 in areas under MGCQ and GCQ Data generated on September 27, 2020, 3:00 PM

HIGHLIGHTS

- Forty Four percent (44%) of passenger and cargo shipping operations were completed in accordance with the ships' CPC.
- Fifty Six percent (56%) of the shipping operations were affected due to the measures implemented in view Code Red Sublevel 2 for the COVID-19.
- Operations of passenger ships were more affected compared to cargo ships. 86% of the cargo shipping operations were completed under normal conditions compared to passenger ships at 35%.
- With cargo shipping still operational, transport of goods amid MGCQ, and GCQ is assured.


PASSENGER AND CARGO SHIPPING IN NUMBERS September 27, 2020

 - 35 Ships Operated Normally



I. STATUS OF SHIPPING OPERATIONS NATIONWIDE



On September 27, 2020, there were 79 passenger and cargo shipping operations conducted wherein 35 or 44% were completed in accordance with their Certificate of Public Convenience (CPC).

Out of the 35 operations completed under normal conditions, the reported movements were mostly in the Bicol Region at 71% and Central Visayas Region at 23%.

Meanwhile, 32% of the passenger and cargo shipping operations were cancelled, all due to the community quarantine measures imposed by the different local government units governing the ships' ports of destination. Mostly affected were operations in the Central Visayas and Eastern Visayas Regions.

Eighteen (18) passenger ships or 28% encountered delays due to the additional measures adopted in view of COVID-19 such as temperature screening and inspections.

Lastly, no passenger and cargo shipping operations were not completed at the time of reporting, as the respective ships were still underway.

II. STATUS OF SHIPPING OPERATIONS BY CLASSIFICATION

Amid the measures in place due to MGCQ, and GCQ, 12 out of 14 (86%) cargo ships still operated normally – are 1 container ships, 1 general cargo ships, 2 LCT ships and 8 Roro cargo ships.

Twenty Three (23) passenger ships completed their voyage – 14 conventional passenger ships, and 9 RoPax ships completed their operations but mostly only carried cargoes during their voyage.

Meanwhile out of the 65 passenger ships, 65% were affected by the measures adopted in view of COVID-19. These measures caused either the cancellation, delay, or uncompleted operations of 42 passenger ships.
