

MARITIME INDUSTRY AUTHORITY SITUATION REPORT - 180

Passenger and Cargo Shipping Operations on September 19, 2020 in areas under MGCQ and GCQ Data generated on September 19, 2020, 3:00 PM

HIGHLIGHTS

- Sixty percent (60%) of passenger and cargo shipping operations were completed in accordance with the ships' CPC.
- Forty percent (40%) of the shipping operations were affected due to the measures implemented in view Code Red Sublevel 2 for the COVID-19.
- Operations of passenger ships were more affected compared to cargo ships. 88% of the cargo shipping operations were completed under normal conditions compared to passenger ships at 49%.
- With cargo shipping still operational, transport of goods amid MGCQ, and GCQ is assured.





I. STATUS OF SHIPPING OPERATIONS NATIONWIDE



On September 19, 2020, there were 58 passenger and cargo shipping operations conducted wherein 35 or 60% were completed in accordance with their Certificate of Public Convenience (CPC).

Out of the 35 operations completed under normal conditions, the reported movements were mostly in the Bicol Region at 43% and NCR and Western Visayas Region at 14%.

Meanwhile, 9% of the passenger and cargo shipping operations were cancelled, all due to the community quarantine measures imposed by the different local government units governing the ships' ports of destination. Mostly affected were operations in the Western Visayas and Central Visayas Regions.

Seventeen (17) passenger ships or 41% encountered delays due to the additional measures adopted in view of COVID-19 such as temperature screening and inspections.

Lastly, no passenger and cargo shipping operation was not completed at the time of reporting.

II. STATUS OF SHIPPING OPERATIONS BY CLASSIFICATION

Amid the measures in place due to MGCQ, and GCQ, 15 out of 17 (88%) cargo ships still operated normally – are 1 LCT ship and 14 oil tankers.

Twenty (20) passenger ships completed their voyage – 10 conventional passenger ships and 10 RoPax ships completed their operations but mostly only carried cargoes during their voyage.

Meanwhile out of the 41 passenger ships, 51% were affected by the measures adopted in view of COVID-19. These measures caused either the cancellation, delay, or uncompleted operations of 21 passenger ships.
