

MARITIME INDUSTRY AUTHORITY SITUATION REPORT - 183

Passenger and Cargo Shipping Operations on September 22, 2020 in areas under MGCQ and GCQ Data generated on September 22, 2020, 3:00 PM

HIGHLIGHTS

- Seventy-five percent (75%) of passenger and cargo shipping operations were completed in accordance with the ships' CPC.
- Twenty-five percent (25%) of the shipping operations were affected due to the measures implemented in view Code Red Sublevel 2 for the COVID-19.
- Operations of passenger ships were more affected compared to cargo ships. 95% of the cargo shipping operations were completed under normal conditions compared to passenger ships at 72%.
- With cargo shipping still operational, transport of goods amid MGCQ, and GCQ is assured.





I. STATUS OF SHIPPING OPERATIONS NATIONWIDE



On September 22, 2020, there were 133 passenger and cargo shipping operations conducted wherein 100 or 75% were completed in accordance with their Certificate of Public Convenience (CPC).

Out of the 100 operations completed under normal conditions, the reported movements were mostly in the Eastern Visayas Region at 30% and Calabarzon Region at 18%.

Meanwhile, 16% of the passenger and cargo shipping operations were cancelled, all due to the community quarantine measures imposed by the different local government units governing the ships' ports of destination. Mostly affected were operations in the Central Visayas and Eastern Visayas Regions.

Twelve (12) passenger ships or 10% encountered delays due to the additional measures adopted in view of COVID-19 such as temperature screening and inspections.

Lastly, no passenger and cargo shipping operations were not completed at the time of reporting, as the respective ships were still underway.

II. STATUS OF SHIPPING OPERATIONS BY CLASSIFICATION

Amid the measures in place due to MGCQ, and GCQ, 19 out of 20 (95%) cargo ships still operated normally – are 1 container ship, 1 LCT ship, 15 oil tankers and 2 Roro cargo ships.

Eighty-one (81) passenger ships completed their voyage – 72 conventional passenger ships and 9 RoPax ships completed their operations but mostly only carried cargoes during their voyage.

Meanwhile out of the 113 passenger ships, 28% were affected by the measures adopted in view of COVID-19. These measures caused either the cancellation, delay, or uncompleted operations of 32 passenger ships.
