

### **MARITIME INDUSTRY AUTHORITY SITUATION REPORT -207**

Passenger and Cargo Shipping Operations on October 16, 2020 in areas under MGCQ and GCQ

#### **HIGHLIGHTS**

- Ninety-four percent (94%) of passenger and cargo shipping operations were completed in accordance with the ships' CPC.
- Six percent (6%) of the shipping operations were affected due to the measures implemented in view Code Red Sublevel 2 for the COVID-19.
- Operations of cargo ships were more affected compared to cargo ships. 67% of the cargo shipping operations were completed under normal conditions compared to passenger ships at 95%.
- With cargo shipping still operational, transport of goods amid MGCQ, and GCQ is assured.





# PASSENGER AND CARGO SHIPPING OPERATIONS IN THE PHILIPPINES IN AREAS UNDER MGCQ and GCQ



### I. STATUS OF SHIPPING OPERATIONS NATIONWIDE



On October 16, 2020, there were 108 passenger and cargo shipping operations conducted wherein 102 or 94% were completed in accordance with their Certificate of Public Convenience (CPC).

Out of the 102 operations completed under normal conditions, the reported movements were mostly in the Eastern Visayas Region at 32% and Bicol Region at 22%.

Meanwhile, 1% of the passenger and cargo shipping operations were cancelled, all due to the community quarantine measures imposed by the different local government units governing the ships' ports of destination. Mostly affected was operations in the Eastern Visayas Region.

Four (4) passenger ships or 4% encountered delays due to the additional measures adopted in view of COVID-19 such as temperature screening and inspections.

Lastly, no passenger and cargo shipping operations was not completed at the time of reporting.

Amid the measures in place due to MGCQ, and GCQ, 2 out of 3 (67%) cargo ships still operated normally – are 1 container ships, and 1 general cargo ships.

One hundred Forty Eight (100) passenger ships completed their voyage – 87 conventional passenger ships, and 13 RoPax ships completed their operations but mostly only carried cargoes during their voyage.

Meanwhile out of the 105 passenger ships, 5% were affected by the measures adopted in view of COVID-19. These measures caused either the cancellation, delay, or uncompleted operations of 5 passenger ships.
