NATIONAL PRINTING OFFICE, a government instrumentality created and existing by virtue of Executive Order No. 285, with principal office address at EDSA corner NIA North Road, Diliman, Quezon City, as represented by its Director FRANCISCO V. VALES, JR., hereinafter referred to as the NPO;

#### -and-

MARITIME INDUSTRY AUTHORITY, a government agency created and existing by virtue of Presidential Decree No. 474, with principal office address at 20<sup>th</sup> Street corner A. Bonifacio Drive, Port Area, Manila, as represented by its Administrator, VADM ROBERT A EMPEDRAD AFP (Ret) and hereinafter referred to as the MARINA.

#### WITNESSETH:

WHEREAS, the MARINA sought the assistance of NPO for the printing and delivery of blank security paper for issuance of various certificates and CPC;

WHEREAS, NPO is willing and able to print and deliver printing and delivery of blank security paper for issuance of various certificates and CPC;

WHEREAS, the printing and delivery of blank security paper for issuance of various certificates and CPC is compliant with the Implementing Rules and Regulations of Republic Act (RA) 9184 or the Government Procurement Reform Act;

**NOW THEREFORE**, for and in consideration of the foregoing, the parties hereto agree to perform and abide by the following terms and conditions, to wit:

- COVERAGE: The MARINA shall procure exclusively from the NPO the printing and delivery of blank security paper for issuance of various certificates and CPC amounting to Five Million Nine Hundred Thirty-One Thousand Nine Hundred Seventy-Six Pesos and 50/100 (P5,931,976.50);
- II. CONSIDERATION: The total price of blank security paper for MARINA shall amount to Five Million Nine Hundred Thirty-One Thousand Nine Hundred Seventy-Six Pesos and 50/100 (P5,931,976.50);
- III. MARINA shall pay the NPO all billed charges, sales invoices, billing statements or statements of account.

amounts shall only be released after the lapse of the warranty period. Provided, however, that the blank security papers delivered are free from patent and latent defects and all the conditions imposed under this agreement have been fully met.

#### **B. MARINA**

- Pay the billed charges, sales invoices, billing statements of account within fifteen (15) days upon issuance of inspection and acceptance report;
- Warrant to the NPO that it has the requisite authority to enter into this Agreement, and is free and clear from any legal responsibility to any person, whether judicial or natural, to engage the services of the NPO for the printing and delivery of blank security paper for issuance of various certificates and CPC.
- VI. STANDARD ARBITRATION CLAUSE. Any controversy of claim arising out of or relating to this agreement or the breach thereof, that cannot be acceptably negotiated by both parties shall be settled by arbitration in accordance with the rules of the "Alternative Dispute Resolution Act of 2004". Judgement on the award rendered by the arbitrator(s) may be entered in any court having jurisdiction thereof.
- VII. DATA PRIVACY. The parties shall abide by and comply with the requirements and procedures on collection, processing and handling of Personal Data, if there is any, specifically enumerated under Republic Act 10173, otherwise known as the Data Privacy Act of 2012.
- VIII. VENUE OF ACTION. In case of litigation arising from or in connection with the contract, the parties agree that the venue of action shall be at the proper court in the City of Manila only.
  - IX. MODIFICATION: Any changes, adjustments, modifications, if there is any in the delivery schedule of blank security papers shall be mutually agreed upon by the Parties at least fifteen (15) days prior to the scheduled delivery.
