## PROCUREMENT OF BLANK SECURITY PAPER FOR ISSUANCE OF VARIOUS CERTIFICATES AND CPC

## Resolution No. 2020-12 Series of 2020

WHEREAS, the MARINA Bids and Awards Committee (BAC), the BAC-Technical Working Group (TWG) for Goods and Services and the BAC Secretariat virtually convened on 29 September 2020 for the presentation of TWG's Post-qualification Evaluation Report relative to the procurement of blank security paper for issuance of various certificates and CPC with an Approved Budget for the Contract (ABC) of Five Million Nine Hundred Thirty Seven Thousand Seven Hundred Fifty Pesos (P5,937,750.00);

**WHEREAS**, it may be recalled that during the opening of quotations, only the National Printing Office (NPO) submitted the quotation, detailed as follows:

WHEREAS, on 04 September 2020, the TWG presented their evaluation report on the quotation of NPO which complied with the technical specifications as well as the financial requirement and recommended NPO as the Recognized Government Printer (RGP) with the Single Calculated Quotation (SCQ) subject to the submission of sample of the required blank security papers for post-qualification. The BAC adopted the said recommendation and declared NPO as the RGP with the SCQ subject to the submission of sample blank security paper as per BAC Resolution No. 2020-11;

WHEREAS, on 24 September 2020, the TWG presented to the BAC the submitted blank security paper sample of NPO, which was received by the BAC Secretariat on 17 September 2020. The BAC approved, in principle, that the submitted sample complied with the technical specifications as required in the Terms of Reference (TOR) and requested the TWG for Goods and Services to finalize and present their post-qualification evaluation report on 29 September 2020;

WHEREAS, on 29 September 2020, the post-qualification evaluation report on the submitted sample which complied with the requirements of the TOR was presented by the TWG for Goods and Services and recommended that the quotation of NPO be declared as the Single Calculated and Responsive Quotation (SCRQ) for the quoted amount of Five Million Nine Hundred Thirty-One Thousand Nine Hundred Seventy-Six Pesos and 50/100 (P5,931,976.50);
