Passenger and Cargo Shipping Operations on 11/16/2020 in areas under MGCQ and GCQ Data generated on 11/16/2020, 3:00:00 PM


HIGHLIGHTS

- Ninety-one percent (91%) of passenger and cargo shipping operations were completed in accordance with the ships' CPC.
- Nine percent (9%) of the shipping operations were affected due to the measures implemented in view Code Red Sublevel 2 for the COVID-19.
- Operations of passenger ships were more affected compared to cargo ships. 95% of the cargo shipping operations were completed under normal conditions compared to passenger ships at 89%.
- With cargo shipping still operational, transport of goods amid MGCQ, and GCQ is assured.

PASSENGER AND CARGO SHIPPING IN NUMBERS 11/16/2020



Shipping Operations

I. STATUS OF SHIPPING OPERATIONS NATIONWIDE



On 11/16/2020, there were 152 passenger and cargo shipping operations conducted wherein 138 or 91% were completed in accordance with their Certificate of Public Convenience (CPC).

Out of the 138 operations completed under normal conditions, the reported movements were mostly in the Eastern Visayas Region at 26% and CARAGA Region at 17%.

Meanwhile, 5% of the passenger and cargo shipping operations were cancelled, all due to the community quarantine measures imposed by the different local government units governing the ships' ports of destination. Mostly affected were operations in the CARAGA and Central Visayas Regions.

Three (3) passenger ships or 3% encountered delays due to the additional measures adopted in view of COVID-19 such as temperature screening and inspections.

Lastly, no passenger and cargo shipping operations was not completed at the time of reporting.

Amid the measures in place due to MGCQ, and GCQ, 52 out of 55 (95%) cargo ships still operated normally – are 11 bulk carrier, 3 container ships, 6 general cargo ships, 12 LCT ships, 19 Roro cargo ships and 1 other cargo.

Eighty-six (86) passenger ships completed their voyage – 52 conventional passenger ships, 31 RoPax ships and 3 fast craft ferry completed their operations but mostly only carried cargoes during their voyage.

Meanwhile out of the 97 passenger ships, 11% were affected by the measures adopted in view of COVID-19. These measures caused either the cancellation, delay, or uncompleted operations of 11 passenger ships.
