

MARITIME INDUSTRY AUTHORITY SITUATION REPORT -232

Passenger and Cargo Shipping Operations on November 10, 2020 in areas under MGCQ and GCQ

Data generated on November 10, 2020, 3:00:00 PM

HIGHLIGHTS

- Ninety-six percent (96%) of passenger and cargo shipping operations were completed in accordance with the ships' CPC.
- Four percent (4%) of the shipping operations were affected due to the measures implemented in view Code Red Sublevel 2 for the COVID-19.
- Operations of passenger ships were more affected compared to cargo ships. 100% of the cargo shipping operations were completed under normal conditions compared to passenger ships at 95%.
- With cargo shipping still operational, transport of goods amid MGCQ, and GCQ is assured.





I. STATUS OF SHIPPING OPERATIONS NATIONWIDE



On November 10, 2020, there were 136 passenger and cargo shipping operations conducted wherein 131 or 96% were completed in accordance with their Certificate of Public Convenience (CPC).

Out of the 131 operations completed under normal conditions, the reported movements were mostly in the Eastern Visayas Region at 27% and Central Visayas Region at 23%.

Meanwhile, 2% of the passenger and cargo shipping operations were cancelled, all due to the community quarantine measures imposed by the different local government units governing the ships' ports of destination. Mostly affected were operations in the Central Visayas and Western Visayas Regions.

Two (2) passenger ships or 2% encountered delays due to the additional measures adopted in view of COVID-19 such as temperature screening and inspections.

Lastly, no shipping operation was not completed at the time of reporting.

Amid the measures in place due to MGCQ, and GCQ, 42 out of 42 (100%) cargo ships still operated normally – are 12 bulk carrier, 2 container ships, 17 LCT ships, 11 Roro cargo ships.

One hundred Forty Eight (89) passenger ships completed their voyage – 55 conventional passenger ships, 31 RoPax ships and 3 fast craft ferry completed their operations **but mostly only carried cargoes during their voyage.**

Meanwhile out of the 94 passenger ships, 5% were affected by the measures adopted in view of COVID-19. These measures caused either the cancellation, delay, or uncompleted operations of 5 passenger ships.
