

MARITIME INDUSTRY AUTHORITY SITUATION REPORT -369

Passenger and Cargo Shipping Operations on 3/27/2021 in areas under MGCQ and GCQ Data generated on 3/27/2021, 3:00:00 PM

HIGHLIGHTS

- Ninety-Three percent (93%) of passenger and cargo shipping operations were completed in accordance with the ships' CPC.
- Eight percent (8%) of the shipping operations were affected due to the measures implemented in view Code Red Sublevel 2 for the COVID-19.
- Operations of passenger ships were more affected compared to cargo ships. 100% of the cargo shipping operations were completed under normal conditions compared to passenger ships at 90%.
- With cargo shipping still operational, transport of goods amid MGCQ, and GCQ is assured.



 - 37 Ships Operated Normally



I. STATUS OF SHIPPING OPERATIONS NATIONWIDE



On 3/27/2021, there were 40 passenger and cargo shipping operations conducted wherein 37 or 93% were completed in accordance with their Certificate of Public Convenience (CPC).

Out of the 37 operations completed under normal conditions, the reported movements were mostly in the Bicol Region at 92% and National Capital Region at 3%.

Meanwhile, no passenger and cargo shipping operations were cancelled.

Three (3) passenger ships or 10% encountered delays due to the additional measures adopted in view of COVID-19 such as temperature screening and inspections.

Lastly, no shipping operations were not completed at the time of reporting.

II. STATUS OF SHIPPING OPERATIONS BY CLASSIFICATION

Amid the measures in place due to MGCQ, and GCQ, 9 out of 9 (100%) cargo ships still operated normally – are 1 bulk carrier, 1 container ships, 1 general cargo ships, 3 LCT ships, 2 Roro cargo ships and 1 other cargo.

Twenty-Eight (28) passenger ships completed their voyage – 21 conventional passenger ships, 5 RoPax ships and 2 fast craft ferry completed their operations but mostly only carried cargoes during their voyage.

Meanwhile out of the 31 passenger ships, 10% were affected by the measures adopted in view of COVID-19. These measures caused either the cancellation, delay, or uncompleted operations of 3 passenger ships.
