#### I. INTRODUCTION

The Maritime Industry Authority (MARINA), a government agency established pursuant to Presidential Decree No. 474 and attached to the Department of Transportation (DOTr), wishes to invite quotations from interested persons/entities/service-providers to provide the needed logistical requirements for the procurement of glass jeepney as souvenirs for the Philippine Candidature to the IMO Council under Category C for 2022-2023 Biennium.

#### II. INCLUSIONS

It includes the procurement and delivery of **one hundred eighty (180) pieces** of jeepney made of glass. The layouts and designs from which the expected output shall be based, will be provided by the end-user.
