
1. Bidders shall provide correct and accurate information required in this form.

4. Quotations exceeding the Approved Budget for the Contract shall be rejected.
5. Award of contract shall be made to lowest calculated and responsive quotation (for goods and infrastructure) or, the highest rated offer (for consulting services) which complies with the minimum technical specifications and other terms and conditions stated herein.
6. Any interlineations, erasures or overwriting shall be valid only if they are signed or initialed by you or any of your duly authorized representative/s.
7. The item/s shall be delivered according to the requirements specified in the Technical Specifications.
8. The MARINA shall have the right to inspect and/or to test the goods to confirm their conformity to the technical specifications.

**I. INTRODUCTION**

The Maritime Industry Authority (MARINA), a government agency established pursuant to Presidential Decree No. 474 and attached to the Department of Transportation (DOTr), wishes to invite quotations from interested persons/entities/service-providers to provide the needed logistical requirements for the **procurement of glass jeepney as souvenirs for the Philippine Candidature to the IMO Council under Category C for 2022-2023 Biennium.**

**II. INCLUSIONS**

It includes the procurement and delivery of **one hundred eighty (180) pieces** of jeepney made of glass. The layouts and designs from which the expected output shall be based, will be provided by the end-user.

The project shall be posted thru Philippine Government Electronic Procurement System (PhilGEPS). The winning service provider will commence the preparation and deliver the final product, to the end-user.

**III. APPROVED BUDGET FOR THE CONTRACT**

The total cost for the procurement of glass jeepney shall be **NINE HUNDRED NINETY THOUSAND PESOS ONLY (Php990,000.000)**, inclusive of Value- Added Tax (VAT), which shall be charged against OSS budget for the Fiscal Year 2021.
