Notice is hereby given that, pursuant to Presidential Decree 474, Republic Act 10635 and its Implementing Rules and Regulation, and all applicable provisions of MARINA Memorandum Circulars SC-2021-03, SC-2021-04, SC-2021-05 and SC-2021-06, effective 09 November 2021, the MARINA has issued new formats for its **Certificates of Competency (COC)** and **Certificates of Proficiency (COP)**, samples of which are shown below. The said change in format was already communicated on 04 November 2021 to the International Maritime Organization (IMO) with a request that the same be likewise disseminated to All IMO Members, Intergovernmental Organizations and Non-Governmental Organizations in Consultative Status.
