- II. CONSIDERATION: The total price of Blank Security Papers for MARINA shall amount to Six Million Four Hundred Twelve Thousand Nine Hundred Thirty-Eight Pesos (P 6,412,938.00);

V. UNDERTAKINGS OF THE PARTIES

A. NPO

- 1. To print and deliver the of blank security paper consists of 1,732 pads Various Certificate (no prefix) and 68 pads CPC (with prefix) for issuance of various certificates and CPC for MARINA Central Office and Regional Offices:
 - a. Procurement of Blank Security Papers for MARINA Central Office and Regional Offices on the following delivery schedule period pursuant to the MARINA approved Terms of Reference:

b. In case of failure to make the full delivery within the time specified above, a penalty of one-tenth (1/10) of one percent (1%) for every day of delay shall be imposed;

- c. Deliver the Blank Security Paper consists of 1,732 pads Various Certificate (no prefix) and 68 pads CPC (with prefix) for issuance of various certificates and CPC for MARINA Central Office and Regional Offices, as scheduled above, in wrapped parcels;
- d. Issue to MARINA the corresponding sales invoice, billing statement or statement of account for every delivery;
- e. To replace any defective Blank Security Paper for the MARINA within seven (7) days upon receipt of the notification of defect, with the same quality and specifications at no cost to the MARINA;
- f. Pursuant to Section 62 of the Revised IRR of RA 9184, to undertake a warranty in an amount equivalent to one percent (1%) of every progress payment, for a minimum period of three (3) months or after consumption of the Blank Security Paper consists of 1,732 pads Various Certificate (no prefix) and 68 pads CPC (with prefix) for issuance of various certificates and CPC for MARINA Central Office and Regional Offices, in order to assure that manufacturing defects shall be corrected and that on time delivery shall be effected. The said amounts shall only be released after the lapse of the warranty period. Provided, however, that the Blank Security Papers delivered are free from patent and latent defects and all the conditions imposed under this agreement have been fully met;
- g. Reimburse the MARINA for any cost of litigation, arbitration or other adversarial proceedings, including attorney's fees, as well as any damages that the MARINA may incur in connection with, or in relation to the execution of this Agreement or the performance of its obligations thereunder.

B. MARINA

- Pay the billed charges, sales invoice, billing statement of account within fifteen (15) days upon issuance of inspection and acceptance report;
- b. Warrant to the NPO that it has the requisite authority to enter into this Agreement, and is free and clear from any legal responsibility to any person, whether judicial or natural, to engage the services of the NPO for the printing and delivery of Blank Security Paper consists of 1,732 pads Various Certificate (no prefix) and 68 pads CPC (with prefix) for issuance of various certificates and CPC for MARINA Central Office and Regional Offices;
- VI. STANDARD ARBITRATION CLAUSE. Any controversy of claim arising out of or relating to this agreement or the breach thereof, that cannot be acceptably negotiated by both parties shall be settled by arbitration in accordance with the rules of the "Alternative Dispute Resolution Act of 2004". Judgment on the award rendered by the arbitrator(s) may be entered in any court having jurisdiction thereof.

- MODIFICATION. Any changes, adjustments, modifications, if there is any in the delivery schedule of Blank Security Papers shall be mutually agreed upon by the Parties at least fifteen (15) days prior to the scheduled delivery.
