**SUPPLEMENTAL BID BULLETIN NO. 1**

The MARINA Bids and Awards Committee (BAC) hereby amends/clarifies/modifies the following provisions relative to the above-mentioned project:

<b>REFERENCE</b>	<b>AMENDMENT/CLARIFICATION/MODIFICATION</b>
Terms of Reference (TOR), Item 4.2	The provision is amended to read as follows:  “The JANITORIAL SERVICE PROVIDER shall deploy a minimum of thirty-five (35) utility personnel including (1) Supervisor who shall render eight hours of work everyday from Monday to Friday, from <b><u>7:00 am to 4:00 pm</u></b> , 8:00 am to 5:00 pm, 9:00 am to 6:00 pm on shifting schedules applicable to the MARINA Central Office or depending on the work assignment of the janitorial personnel of the satellite offices;”
TOR, Item 4.4 36 reams scrubbing pad	To clarify, the scrubbing pad shall be for dishwashing and not for floor polishers.
TOR, Item 5.4	To clarify, Philhealth premium contribution shall be at 4 percent (4%), following Philhealth Memorandum Circular No. 2019-009.
TOR, Item 6.3	The provision is amended to read as follows:  “The MARINA and the JANITORIAL SERVICE PROVIDER must be compliant with the DOLE Department Order No. 18-A, s. 2011, <b><u>as amended</u></b> , in particular, Place of Work; Compliance With Labor Standards and Occupational Health and Safety, and Administrative Fee, which states that: Xxxxxx...”
Bid Documents, Annex “A”	To clarify, the bidder must attach a copy of at least three contracts listed in its Statement of Ongoing Government and Private Contracts.
Bid Documents, Proposed Cost Distribution Form	Computation for 13 month pay: (DW x <b><u>261</u></b> /12)/12

Bid Documents, Proposed Cost Distribution Form	12% VAT shall be computed based on total contract price, as decided in BIR Ruling No. 213-2015, dated 19 June 2015.
