6. Quotations exceeding the Approved Budget for the Contract shall be rejected.



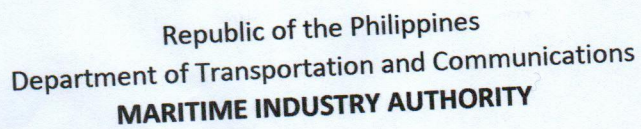
