MISMO-RELATED UPDATES

Pursuant to RA 10635 and its revised Implementing Rules and Regulations, the relevant provisions of the 1978 STCW Convention and Code and RA 11032, "Ease of Doing Business and Efficient Government Service Delivery Act of 2018", notice is hereby given that effective 16 May 2022, the MARINA will be fully implementing MARINA Circular SC-2022-02 "Revised Fees Covering Certificates of Competency (COC) and Certificates of Proficiency (COP)" and MARINA Advisory 2022-04, "Amendment to MARINA Advisory 2021-65". In view of the foregoing, the following MISMO-related updates and guidelines are hereby published:

#### A. SEAFARERS

- All applications lodged in MISMO that are still in **Draft** status for more than a week will be considered as **Inactive** and will therefore be removed from the system.
- Previously filed applications that are still being subjected to evaluation, may it be under Online or Final Evaluation status and other pending applications that require resubmission of documents, once approved, shall be charged based on the existing (old) fees.
- Seafarers who wanted to avail of the new fees are advised to cancel their existing applications and re-apply. This will however entail a slight delay as the application will pass through the same process.
- Personal appearance will not be required any more for Regular Applications except on instances where submitted documents need to be clarified by the Evaluators and the processing of Expedite Applications at the MARINA Central Office.
- 5. Onboard applications for revalidation shall be filed personally by the concerned seafarers thru their MISMO Accounts at least three (3) months before the expiration of the certificates to be revalidated.
- Transfer of payments for wrong applications will no longer be allowed and will . be forfeited in favor of MARINA.
- 7. Effective 01 July 2022, MARINA shall only consider sea services encoded by

LMAs and medical results encoded by MFOWS, as confirmed by the Medical Practitioner, in the MISMO accounts of the seafarer-applicants.

#### **B. LICENSED MANNING AGENCIES**

- Onboard Processing of COCs and/or COPs by Licensed Manning Agencies' company representatives are hereby suspended until further notice since all concerned seafarers onboard are required to file their application for revalidation personally thru their respective MISMO Accounts.
- Further to MARINA Advisory 2022-05, "Guidelines on the Encoding of Relevant Information in the MARINA Integrated Seafarers Management Online (MISMO) System Relative to Medical Fitness and Sea Service", listed in Annex A are MARINA-Compliant LMAs. LMAs shall encode the sea services of their seafarers in the MISMO system.
- Starting 01 July 2022, MARINA shall process COC/COP applications of seafarers based on the encoded information to the MISMO by MARINA-Compliant LMAs.
- 4. To ensure that only qualified seafarers are sent on board, LMAs are reminded to verify the authenticity of the STCW Certificates of their crew taking into consideration the verification guidance as contained in MARINA Advisory 2021-65 and the certificates' format as contained in MARINA Advisory 2022-04.

#### C. MEDICAL PRACTITIONERS

- 1. Further to MARINA Advisory 2022-05, "Guidelines on the Encoding of Relevant Information in the MARINA Integrated Seafarers Management Online (MISMO) System Relative to Medical Fitness and Sea Service", listed in Annex B are MARINA-Compliant Medical Facilities of Overseas Workers and Seafarers (MFOWS) together with their accredited Medical Practitioners. MFOWS, as confirmed by the examining Medical Practitioners, shall encode relevant medical information of the seafarers in the MISMO system.
- Starting 01 July 2022, MARINA shall only process COC/COP applications of seafarers whose medical records, confirmed by accredited Medical Practitioners, were supplied by MARINA-Compliant MFOWS.
- MARINA-Compliant MFOWS, shall submit to MARINA, Summary of Examined Seafarers, not later than 0800Hrs the following day (in the case of those examined on a Saturday, submission should be not later than 0800Hrs, Monday) at clinic\_reports@mail.marina.gov.ph using Annex C as format.
