



INTRODUCTION

The Maritime Industry Authority (MARINA) was created on June 1, 1974 with the issuance of Presidential Decree No. 474 to integrate the development, promotion and regulation of the maritime industry in the country. With the creation of the Department of Transportation and Communications (DOTC) by virtue of Executive Order No. 546, MARINA was attached to the DOTC for policy and program coordination on July 23, 1979.

Guided by the 10-Year Maritime Industry Development Plan (MIDP), the MARINA envisions to accelerate and expand domestic shipping services that shall render the country's economic environment more conducive for flourishing of businesses, influx of investments and facilitation of trade within the country; build modern and seaworthy ships through a globally competitive ship building, ship repair and ship breaking industry; and promote and develop the Philippines as human resource capital for ship management and other maritime services.

Since the appointment in 2020, VADM Robert A Empedrad AFP (Ret) led the Agency in ensuring that its thrust of providing quality service to the stakeholders, particularly the seafarers, shipowners & other maritime-related entities are met.

MARINA has set the Vision of realizing a globally competitive Philippine maritime industry and the Mission of leading a progressive maritime administration for safer people, safer ships, and cleaner environment. The Agency resolutely adheres to its Vision and Mission by implementing coordinated policies, projects and programs which aims to improve the overall contributions of the maritime industry throughout the country.

On Personal Services

As indicated by the utilization rate, a deficiency in PS allotment amounting approximately to P30 Million is expected. Special Budget Request (SBR) for the issuance of Special Allotment Release Order (SARO) with corresponding Notice of Cash Allocation shall be submitted to the Department of Transportation (DOTr) for indorsement to the Department of Budget and Management not later than August 15, 2022.

On Maintenance and Other Operating Expenses (MOOE)

As can be gleaned from the summary of the budget utilization, the obligation rate for MOOE as of June 30, 2022 is 53.76%. The said obligation rate is a resultant effect of a relentless effort to adopt cost-cutting measures and deferment of some priority programs, activities and projects (PAPs) due to a foreseeable deficit. This validates the need of the agency to obtain other sources of funds to support the funding for priority PAPs of MARINA until December 31, 2022. Hence, to date, an SBR for the issuance of SARO relative to the MARINA Special Provision for the use of income from Tonnage Fee in the amount of P25.436 Million is pending with the DBM.

On Capital Outlays (CO)

The P25.717 Million allotments for CO consist of the following:

- Procurement of Motor Vehicles P21 Million
- Procurement of Furniture and Fixtures and Office Equipment for the newly constructed MRO V Office Building – P4.717 Million.

• The SARO amounting to P21 Million for the procurement of vehicles was released by the DBM last 23 June 2022. The procurement process for the motor vehicles is ongoing.

To date, an appropriation in the FY 2022 GAA for CO amounting to P94 Million for the construction, rehabilitation and renovation of various MARINA Office Buildings is still unreleased. An SBR, attached with the necessary supporting documents has been forwarded to the DOTr for indorsement to the DBM.

The decrease in revenue for the Clearance and Certification Fees was due to:

- a. Issuance of MARINA Advisory No. 2021-18 dated March 31, 2021, "Termination/Cancellation on the Issuance of the STCW Certificate of Endorsement (COE) in the Certification of Filipino Seafarers who serve the capacity as Marine Deck and Marine Engine Officer". The COE was integrated in the Certificate of Competency (COC), hence the STCW Office no longer issues COE to the seafarers; and
- b. Issuance of MARINA Circular No. SC-2022-02 dated April 13, 2022, "Revised Fees Covering COC and Certificates of Proficiency (COP)". This Circular reduced the processing fees by 50% for the issuance, revalidation and replacement of COCs and COPs.

The decrease in the Other Processing Fees is mainly due to:

Issuance of MARINA Advisory No. 2022-06 dated January 31, 2022 "Cost of Issuance of Seafarers Record Book (SRB)". The following guidelines are implemented under this advisory:

- a. The MARINA shall issue SRB at no cost to the applicant applying for the first time who has not been previously issued with a Seaman's Book or the Seafarer's Identification and Record Book (SIRB).
- b. The MARINA shall grant fifty percent (50%) discount on the cost of renewal/reissuance of expiring or expired/lost or damaged SIRB and SRB booklet.

II. IMPLEMENTATION OF PROGRAMS/PROJECTS/ACTIVITIES

A. STATUS [NEW, ONGOING, PLANNED]

ONGOING PROGRAMS / CONSTRUCTION PROJECTS

1. BlockChain Enabled Certification System

The Blockchain technology is an ongoing project of MARINA which aims to integrate into one web-enabled information system all MARINA frontline processes / transactions relating to vessels and seafarers.

The application system will ensure that data are well-protected and secured and that they are generated in real-time.

The system will also allow authentication/verification of certificates, permits and other MARINA issuances.

2. Hybrid Trimaran Fast Craft Passenger Cargo Vessel using Multi-Engine and Alternative Energy sourced from Ocean waves

In partnership with DOST-PCIEERD, the project covers design, construction and testing of a pump that uses renewable energy from ocean waves for electrical needs of a hybrid Trimaran fast craft passenger cargo vessel



The MARINA serves as the coordinating/collaborating agency under the Science and Technology for Marine/Maritime Transport Application (STMTA).

3. Construction of MARINA Regional Office VIII Building



A four-storey building located at the Government Center, Candahug, Palo, Leyte. It has an approved budget amounting to P55,050,000.00 which is downloaded to the Department of Public Works and Highways (DPWH) as the implementing agency.

Started in September 2021, the MRO VIII has already requested updates on the implementation/construction of the building from the DPWH. The target date of completion is in October 2022.

4. Construction of MARINA Regional Office XIII Building

Located in Surigao City, the allocated budget amounting to P31,710,000.00 covers the following phases: Civil Works; Mechanical Work; Electrical Work; and, Sanitary/Plumbing Works.

Phase 2 of the project amounting to P10,555,300.00 has been transferred to the implementing agency, DPWH Surigao del Norte DEO. This is currently in the preparation phase of the bidding process through negotiated contract, pending submission of Memorandum of Agreement between MARINA and DPWH. During the meeting with DPWH, it has been



resolved that Phase 2 of the project will be dedicated to the completion of the civil, mechanical, electrical, sanitary/plumbing aspects of the new building.

Phase 3 of the said building has been endorsed by the Regional Development Council of the National Economic and Development Authority (NEDA) in CARAGA Region for funding which will cover architectural works, office furniture, fixtures and equipment. The project is already approved and funded under GAA 2022 Appropriations and is now waiting for the release of Notice of Cash Allocation (NCA).

PLANNED - PROGRAM / CONSTRUCTION PROJECTS

1. Construction of MARINA Regional Office X Building

Located in El Salvador City, Misamis Oriental, the MARINA RO X and DPWH-X had just signed a Memorandum of Agreement to undertake the project. The latter commits to commence the construction within the year.

The project amounting to P68,300,000.00 includes the cost of Engineering and Administrative Overhead (EAO), Detailed Architectural and Engineering Design (DAED), and Civil, Mechanical, Electrical, and Sanitary/Plumbing Works.

B. ACCOMPLISHMENTS

1. Awards and Recognitions

a. ISO Certification of the MARINA-STCWO and Regional Offices



The Maritime Industry Authority-STCW Office (MARINA-STCWO)'s Quality Management System (QMS) was recertified by the Bureau of Veritas under the ISO 9001:2015 standard. Along with this, the STCW Units of MARINA Regional Office IV (MRO 4) - Batangas, under the leadership of Director Engr. Emmanuel B. Carpio; the MARINA Regional Office VI (MRO 6) - Iloilo and Bacolod Extension Office, led by Director Annabell P. Lagas; and the MARINA Regional Office VII (MRO 7) spearheaded by Director Felisa N. Orongan were likewise granted ISO 9001:2015 Certification for meeting the requirements of the management system standards.

The ISO Certification of the QMS is consistent with MARINA's mission to ensure that Filipino seafarers are well-educated, well-trained, and well-equipped with knowledge and competencies aligned with national and international standards in order to develop them into a globally-competitive seafaring workforce. MARINA takes pride in its ISO 9001:2015 QMS certification, as it represents a testament to its commitment to continuously improve its maritime services and achieve its goals of the delivery quality and efficient services for overall customer satisfaction.

b. HR Prime Bronze Medal Awards



In line with the intention to Strengthen MARINA as an organization, the Civil Service Commission acknowledged MARINA with the Bronze Award pertaining to the Program to Institutionalize Meritocracy and Excellence in Human Resource Management last January 2022.

c. Commission on Audit (COA) - Unqualified Opinion



The MARINA got the highest audit mark from its COA independent auditor for last year, 2021. The audit report stated that the financial statements present fairly, in all material respects, the financial position of the MARINA as at December 31, 2021. An unqualified opinion is given by the auditors to government offices that have fairly presented their financial statements. and conform to public sector accounting standards. In a nutshell, it means that the agency's financial records are clean.

d. 100% Resolution Rate of 8888 Complaints

In line with the Agency's thrust towards eradication of corruption and strengthening the policies and procedures to promote good governance, the MARINA received a palace commendation of resolution to Citizen's Complaints / Concerns.

e. ARTA - Best Performing Agency

The Maritime Industry Authority (MARINA), along with several government agencies in the country, received recognition from Anti-Red Tape Authority (ARTA) for consistently earning top scores in the Pre and Post Diagnostic Tests during the threemonth-long Phase II: Regulatory Impact Assessment Manual Training held from April to July 2022.



The training aimed to capacitate personnel on the different tools mentioned in the RIA Manual such as Benefit Cost Analysis, Standard Cost Model, and Multi-Criteria Decision Analysis. Further, different lenses of analysis on areas such as Gender and Social Inclusion, Environment, Disaster Risk, and Competition were also included in the training.

Through participating in this training, the MARINA will be able to design and evaluate policies and regulations in a systematic process that will enhance the quality of existing and proposed regulations.

2. 10-Year Maritime Industry Development Plan (MIDP)



On February 22–23, 2022, in the MARINA Board Room, a two-day session was held to finalize the MARINA Strategic Voyage Plan and MIDP Abridged Report. Heads/directors of MARINA offices handling MIDP programs were invited to participate in the abovementioned face-to-face workshop under Special Order (SO) No. 129-22 with the goal of producing an output suitable for publication. Participants discussed and modified the institutional arrangements and program components of the ten (10) MIDP Priority Programs to better suit the times. The Administrator received the final draft of the condensed MIDP in March 2022.

A Special Order to reconstitute the MIDP Program Team Composition and name Focal Offices as Program Chair or Co-Chair and Vice-Chairs was

approved last March 30th in accordance with Section 5 of the Presidential Decree (PD) No. 474 series of 1974, which requires the MARINA to annually update the 10-Year MIDP. The Implementation Plan for the MIDP programs, which includes Program Milestones and the Results Matrix, was then amended by the PPS. To update the aforementioned templates, the MIDP program teams held their specific Focus Group Discussions (FGDs) from April to May 2022. This allowed them to submit their amended initial write-ups to PPS. Additionally, in May 2022, planning for the 2022 Philippine Maritime Industry Summit began.

Through the Planning and Policy Service unit of MARINA a draft Executive Order (EO) was crafted on May 5, 2022, adopting the 10-Year MIDP and submitted on May 31, 2022 to the Administrator. Thereafter, it was forwarded to the Department of Transportation (DOTr) for subsequent endorsement to the Office of the President.

3. MARINA Strategic Voyage Plan 2028

The Maritime Industry Authority (MARINA), through the Planning and Policy Service (PPS) conducted pocket workshops with Central Office Directors and Focal Persons to review their respective strategic deliverables for 2022 under the MARINA Strategic Voyage Plan 2028 which was finalized on 02 June 2022. The PPS also spearheaded the signing of Pledge of Commitment by Program Heads to show their utmost sincerity and commitment to fulfill their responsibilities and ensure that all deliverables assigned thereof are accomplished.

a. Endorsement of the MARINA GAD Plans and Budget for CY 2022

As our Agency's support to the gender mainstreaming and with reference to Sec.37 of MCW-IRR wherein "All agencies, offices, bureaus and all government instrumentalities and others concerned shall formulate the annual GPBs within the context of their mandates"

MARINA's draft 2022 GPB was first submitted on 8 November 2021 through the Gender Mainstreaming and Monitoring System (GMMS). The review was facilitated by the Philippine Commission on Women (PCW) where their comments and suggestions were provided for MARINA to consider in the revision. In order to strengthen our collaboration with the PCW, the PPS-PADMO led by Dir. Luisito U. Delos Santos requested for a virtual meeting with PCW key personnel including the GAD Plan reviewer to seek guidance and clarification on the comments.

Last 24 May 2022, MARINA received PCW's endorsement for reaching the required minimum five percent (5%) GAD budget allocation and for being compliant with all the requested revisions in the GPB, within the prescribed/agreed deadline.

b. 2022 Women's Month Celebration



As part of the celebration of National Women's Month (NWM), the Maritime Industry Authority has expressed its support to the said celebration by issuing a directive to undertake specific and attainable activities.

The NWM serves as a venue to showcase women's successes and address ongoing and developing women empowerment and gender equality topics and concerns, difficulties, and commitments.

With the 6-year theme, "We Make Change Work for Women", the 2022 celebration focused on the sub-theme: "Agenda ng Kababaihan, Tungo sa Kaunlaran" which calls to include women's concerns in the government agenda and enable more

women to implement and demand programs and services that can bring the country closer to narrowing the gender gaps.

c. Celebration of the International Day for Women in Maritime



The General Assembly of the International Maritime Organization in its 32nd session in December last year adopted Resolution A.1770 (32) declaring 18 May of each year as the International Day for Women in Maritime. The resolution is response to the United Nations Assembly Resolution General A/RES/74/128, calling upon Governments all other and stakeholders systematically to

provide gender perspective into the implementation of the 2030 Agenda for Sustainable Development, and requests the entities of the United Nations system to ensure effective support for the efforts of Member States towards the achievement of gender equality and the empowerment of women and girls.

Aiming to provide an avenue for women to resolve challenges, and barriers in a male-dominated industry, the Maritime Industry Authority (MARINA) celebrated the International Day of Women in Maritime through a series of panel discussions, on 18 May 2022 at the MARINA Central Office, in Port Area, Manila.

d. MARINA Strengthens Partnership with Women in Maritime Philippines (WIMAPHIL)

The oath-taking of the new set of officers of the WIMAPHIL MARINA sub-chapter was conducted last 18 May 2022, which coincides with the International Day for Women in Maritime.

The Women in Maritime Philippines Association (WIMAPHIL) was formed as part of the initiatives forwarded by the MARINA and the International Maritime



Organization (IMO) to encourage and support women in the maritime industry. The WIMAPHIL formulates programs that coincide with the UN's Millenium Development Goals (MDGs), and launches activities that raise awareness about the issues that women face today, especially in the maritime sector.

Ms. Merle Jimenez-San Pedro, President of Women in Maritime Asia (WIMA-ASIA) and WIMAPHIL, expressed her appreciation to the VADM Empedrad and Atty. Sharon D. Aledo for welcoming WIMAPHIL into MARINA and for the Agency's continued support and commitment to the United Nations 2030 Agenda for Sustainable Development Goal (SDG) specifically SDG No. 5 which is Gender Equality.

e. Modified Basic Safety Training (MBST) with Gender and Development Awareness

The MBST is conducted as part of the Agency's initiatives to continually support the needs of fishing and recreational boat operators.

The MBST module includes several discussions on Fire Prevention and Fire Fighting (FPFF) module which informed participants of the common causes of fires on ships, namely: careless smoking, spontaneous ignition, faulty electrical faults, oil transfer, welding, etc. The Elementary First Aid (EFA) module includes discussion on the importance of understanding first-aid principles, especially for the captain and crew of the ship. Another module is the Personal Safety and Social Responsibility (PSSR) and Personal Survival Technique (PST) modules, that discuss the standard precautionary measures to prevent pollution of the marine environment and the importance of observing safe working practices onboard ships.

To promote gender sensitivity among the participants, the MBST also included an orientation on Gender Sensitivity Training. Laws related to Gender and Development (GAD) such as RA 7877 Anti-Sexual Harassment Act of 1995 and RA 8353 or the Anti-Rape Law of 1997 are incorporated in the module to raise awareness among the participants who were predominantly male.





5. Local and Foreign Engagements

a. LOCAL ENGAGEMENTS

Memorandum of Agreement with Development Bank of the Philippines



The MARINA initiated a partnership with the Development Bank of the Philippines through signing of MOA last June 2022, allocating a total of P50-billion fund in support of the implementation of the MIDP in line with the directive of the Administrator to pursue with Vigor the Priority Programs of the MIDP.

Memorandum of Understanding with Seaversity

As the MARINA aimed to establish the development of competency framework under the 10-Year MIDP, the MOU between the MARINA and Seaversity was signed last 25 June 2022, during the Seafarers' Day.

The MOU expresses the understandings and intentions of the



Parties in relation to collaboration on the competency development framework under the Maritime Industry Development Plan (MIDP) through the application of simulation technology.

MOU with WWF - Philippines

The MARINA entered a partnership with the World Wide Fund for Nature – Philippines, a non-stock, non-profit organization engaged in the conservation and preservation of the environment in selected areas of the Philippines, which is directly related with the Agency's MIDP Program 10 "Implementation of the Philippine Strategy on the Marine Environment Protection."

b. FOREIGN ENGAGEMENTS

Memorandum of Understanding with Kongsberg Digital



Together with the Seaversity, the MARINA also inked partnership with Kongsberg Digital for the development of the same priority agenda.

The parties share the understanding of maritime education and training (MET) and the recognition that it is only feasible to secure and preserve

highly qualified human resources in the maritime industry through effective and quality MET.

The MOU expresses the understandings and intentions of the Parties in relation to collaboration on the competency development framework under the Maritime Industry Development Plan (MIDP) through the application of simulation technology.

 Bilateral Agreements between the Philippines and Panama

The MARINA also discussed bilateral agreements with Panama, particularly on the recognition of certificates, continuous employment of Filipino Seafarers and promotion of mutual maritime interests last January 2022.



 First Meeting of the Regional Task Force (RTF) on Biofouling Management for East ASEAN Seas Region

Consistent with its commitment of protecting and ensuring the sustainability of the marine environment, the Philippines, as one of the Lead Partnering Countries (LPC) of the GloFouling Partnerships Project, through the Maritime Industry Authority (MARINA), led the first meeting of the Regional Task Force (RTF) on Biofouling Management for East ASEAN Seas Region on 28 April 2022 via video conference.

2nd Global Project Task Force (GPTF) Meeting



The Philippine delegation, through the Maritime Industry Authority (MARINA), shared its best practices in protecting and conserving the marine environment during the 2nd Global Project Task Force (GPTF) Meeting of the GEF-UNDP-IMO GloFouling Partnerships Project held on 11 to 13 April 2022 at the International Maritime Organization Headquarters in London. (IMO) United Kingdom.

Workshop on Safety, Energy Efficiency of Ships

Together with the World Maritime University and the University of Strathclyde, the MARINA facilitated a Virtual Workshop to present the initial findings of the FSA-P and ENV-P Projects including the results of verification, challenges, gaps and opportunities as well as feasible solutions to reduce risk of domestic ferry hazards and incidents in the country.



42nd ASEAN Maritime Transport Working Group (MTWG) Meeting



The Philippines, through the Maritime Industry Authority (MARINA) and in coordination with the Department of Transportation (DOTr), conveyed its appreciation to the ASEAN Member States (AMS) for their support to the re-election of the country to the IMO Council under Category C for Biennium 2022-2023 during the 42nd ASEAN Maritime Transport Working Group (MTWG) Meeting held on 09 to 10 March 2022 via video conference.

The 42nd ASEAN MTWG Meeting discussed the decisions made during the ASEAN Senior Transport Officials Meeting (STOM) in November 2021, progress of implementation of maritime-transport related measures under the Kuala Lumpur Transport Strategic Plan (KLTSP), COVID-19-related initiatives, working group's work plan, cooperation with transport-affiliated private sector organizations and dialogue partners, and ASEAN's partnership with the IMO.

Meeting with PHL IMO GMAs

In line with the promotion of the maritime industry, the MARINA convened its first meeting with the appointed IMO Goodwill Maritime Ambassadors (GMAs) of the Republic of the Philippines to reach new target audiences to educate and inform on the importance of shipping and the role of IMO last 05 May 2022.



Discussed during this meeting are the accomplishments and plans of the IMO GMAs in promoting the above advocacies.

Candidature of the Philippines to the IMO Council under Category C



The MARINA Board approved and issued Board Resolution No. 2022-01-02 recognizing the need to ensure the reelection of the Philippines to the IMO Council under Category C for Biennium 2024-2025. The said Board Resolution was transmitted to the DFA being one of our partner agencies in this campaign.

Efforts Related to the IMO Member State Audit Scheme (IMSAS)

 Virtual Writeshop on the Additional Pre-Audit Information Requirement of the IMO Member State Audit Scheme (IMSAS)

In preparation for the Philippines' audit under the IMO Member State Audit Scheme (IMSAS) in October 2023, an Inter-Agency Writeshop was hosted virtually by MARINA last 07-08 April 2022 dedicated to the



initial review of the additional pre-audit information (PAI) requirement of the remote IMSAS. As a supplementary requirement, it requires the Member State to provide response to a set of questions, in addition to the pre-audit

questionnaire which serves as a significant basis for the detailed planning and initial assessment of the audit team.

 Annual Report on the Implementation of Executive Order No. 84, series of 2019, and IMSAS National Work Programme

Pursuant to Executive Order No. 84, series of 2019, the IMSAS Council and Technical Working Group, through the MARINA, submitted the Annual Report to the Office of the President for CY 2021 on the implementation of the abovementioned EO and the Philippine Maritime Strategy on the Implementation and Enforcement of Relevant IMO Instruments for 2020-2024 as IMSAS National Work Programme.

 Approval and Adoption of Proposed Resolution on the Expansion of the IMSAS Technical Working Group Membership and Adoption of Administrative and Information Technology-Related Matters

The MARINA, as the IMSAS Secretariat, submitted a proposed Resolution to the IMSAS TWG to expand its membership to government entities performing flag, coastal, and port State obligations such as the National Telecommunications Commission (NTC), Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), Subic Bay Metropolitan Authority (SBMA) and other port authorities. The TWG during its meeting last 13 June 2022 approved the draft Resolution and its subsequent endorsement to the IMSAS Council for final approval.

Efforts Related to the Inter-Agency Coordination Committee to Facilitate the Ratification and Accession and Implementation of Maritime Conventions (ICCFRAIMC)

 Executive Order No. 159, series of 2021 entitled, "Adopting an Integrated Approach in the Ratification and Accession to the International Maritime Organization Conventions and Instruments and Reconstituting the Inter-Agency Coordinating Committee for the Purpose"

Approval of Executive Order (EO) No. 159 series of 2021 on 28 December 2021 by President Rodrigo Roa Duterte and its release on 13 January 2022. The country's strong determination to fulfill its maritime commitments and responsibilities stemming as a responsible Member State is demonstrated by the issuance of this EO. Through this EO, the government is obligated to conduct national interest studies in order to evaluate whether maritime instruments are applicable to the nation. The nation may be in a position to choose the advantages of a certain marine treaty or document for itself as well as the obligations resulting therefrom.

6. Pandemic Response

The MARINA, as the regulatory agency which is mainly involved in activities of the maritime industry, is also responsible for promoting safety for its stakeholders in the midst of the COVID-19 pandemic.

The Agency has launched various initiatives and continually implement programs to alleviate the negative effects of the pandemic in the maritime industry.

• 100% Passenger Capacity for Maritime Transport

In line with Section 6 of the Guidelines for Areas Under Alert Level 1 as issued by the Inter-Agency Task Force, the MARINA allowed 100% passenger capacity for maritime public transport in and out of Alert Level 1 Areas by issuing an Advisory.



• "No Vax, No Ride" Policy in Domestic Ships



With the continued easing of policies with regard to passenger capacity, the MARINA likewise issued an Advisory in line with the Department Order No. 2022-01 of the DOTr disallowing unvaccinated passengers to embark and avail of the services provided by passenger vessels in order to avoid the risk of another COVID-19 outbreak.

7. Good Governance

As part of the National Government, the MARINA put a premium on implementing effective and efficient programs that are responsive to the needs of the agency.

Free SRBs and 50% Discount for Renewal

In line with the directive of the SOTr, MARINA started issuing the Seafarer's Record Book (SRB) at no cost for 1st time applicants and granted a 50% discount for its Renewal and Re-issuance last February.

8. Other Notable Accomplishments

Inauguration of the Maritime Training Institute



In line with the Administrator's agenda to capacitate MARINA personnel, the MARINA inaugurated its own training and research development Arm at Panaad Park, Brgy. Mansilingan, Bacolod City in Negros Occidental last 24 May 2022. The inauguration was also directed towards improving the morale and welfare of employees.

Celebration of the Seafarer's Day

This annual event which was first observed in 2011, pays tribute to the lifeblood of sea trade, the seafarers, in recognition of their invaluable contribution to international trade and the world economy, oftentimes involving extreme risks for them and their families.

This year's Seafarers Day celebration spotlights **#SeafarerJourney** which calls for all seafarers to share their voyage stories, then and now, as the world and the working environment transitions to different changes.

During the celebration, Filipino seafarers and maritime stakeholders around the world witnessed the showcase of talents, video messages





from stakeholders, simultaneous mass oath-taking of Merchant Marine Officers in Manila, Iloilo, Cebu, and Davao, as well as the launching of the Search for Exceptional Bravery at Sea Awardees to be recognized during the National Maritime Week (NMW) Celebration coming September

The celebration was successfully concluded by the signing of Memoranda of Understanding (MoU) between the MARINA and the Kongsberg Digital AS, and the Seaversity, Inc. with an end goal of delivering a globally competitive Philippine maritime industry.
