# **CONTRACT AGREEMENT**

"Procurement of Brand New One (1) Sports Utility Vehicle (SUV) for MARINA Regional Office X"

## KNOW ALL MEN BY THESE PRESENTS:

THIS AGREEMENT is made this **7** thay of 2023 2023 between **Maritime Industry** Authority (MARINA) of 20<sup>th</sup> St. cor. Bonifacio Drive, Port Area, Manila (hereinafter called "the Entity") of one part and **Fast Autoworld Philippines Corporation (FAPC)** Gusa Hiway, Cagayan de Oro City (hereinafter called the Supplier) of the other part:

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly, "Procurement of Brand New One (1) Sports Utility Vehicle (SUV) for MARINA Regional Office X" and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of One Million Six Hundred Fifty-Five Thousand Pesos (P 1,655,000.00) (hereinafter called "the Contract Price").

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation:

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conformed thereto; and
- v. Other contract documents that may be required by existing laws and/ or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents of information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.




